\* 7:10 p.m.: Brenda presented a traffic safety discussion concerning P.C.N.A. streets as well as its surroundings throughout the other city transportation. Her presentation launched several questions from residents which were answered by Brenda in an acceptable and informative manner. Sergeant Hennely also assisted in answering a couple questions (e.g. the "dos" and "don'ts" of parking cars).

\* 8:40 p.m.: Meeting was adjourned; however, conversations continued in groups outside the City Hall.
