Subject: Contract Award for the Bland-Rosemont Intertie Water Line

Purpose

Provide Council approval for the Bland-Rosemont Intertie Water Line Project.

Question(s) for Council:

Should the City spend Water SDC funds on a water transmission main to connect the Bland and Rosemont Pressure Zones?

Public Hearing Required:

None required.

Background & Discussion:

The Bland-Rosemont Intertie Water Line will provide needed backup supply to the Rosemont Pressure Zone due to its limited reservoir capacity. This project is in the current adopted Budget, Six-Year Capital Improvement Plan, and Water Master Plan and will be done in coordination with the Bland Intertie Pump Station which is currently under construction. Sidewalk construction from Bland Circle to Weatherhill Road will be completed as part of this project.

The project was advertised and bid in accordance with the West Linn Local Contracting Rules. A bid opening was held on July 23, 2014, with a total of eight bids received as indicated on the attached bid results form. Trench Line Excavation was the lowest responsive and responsible bidder with a bid of \$530,530. References have been verified and are positive.

Budget Impact:

\$530,530 to the Water SDC Fund.

Council Options:

- 1. Award the contract to the lowest responsive and responsible bidder, Trench Line Excavation.
- 2. Cancel the bid solicitation and retain the capital funds.

Staff Recommendation:

Approve the contract with Trench Line Excavation.

Potential Motion:

Acting in the capacity of the Local Contract Review Board, pass a motion authorizing the City Manager to sign a contract with the low bidder, Trench Line Excavation, in the amount of \$530,530 for the Bland-Rosemont Intertie Water Line.
