This fall, the Council will consider specific reforms designed to address ineffective and inefficient regulatory barriers in our codes and regulations. This project has advanced through our Economic Development Committee and Planning Commission. Citizens are encouraged to review the list of code amendments currently being considered and provide input.

Some of the items being considered include updates to the Economic Development goals and policies in our Comprehensive Plan; adding flexibility to our development regulations; modifications to our procedures to hear land use appeals; and streamlining regulations to promote and support desirable development and business activity in West Linn. Willamette Falls Legacy Project: Re-Imagining Willamette Falls

The City of Oregon City welcomes the perspectives and viewpoints of West Linn residents as they embark on the Willamette Falls Legacy Project.

The Blue Heron Paper Company, which closed its doors in 2011, was the last in a succession of businesses that contributed to a strong working waterfront in Oregon City. The 23 acre site formerly occupied by the mill are is for sale, with purchasers interested in the site. With master planning underway, Oregonians have a once in a lifetime opportunity to help define how this area is transformed for economic redevelopment, public access, healthy habitats, and historical and cultural interpretation.

Project leaders include the State of Oregon, Metro, Clackamas County, Oregon City, and the Trustee or Designee (if the site is sold) of the former Blue Heron Paper Company site. With their leadership and support, the Willamette Falls Legacy Project planning process launched this summer to envision how Oregonians can establish a statewide legacy and reconnect with this incredible natural and cultural asset.

This fall you'll be able to review and weigh in on the concept alternatives. Do they look right to you? Is it an accurate reflection of the thoughts and dreams you gave us in combination with the opportunities and constraints of the site? Your contribution to the vision and framework for the site shapes this statewide significant project with the voice of Oregon. Connecting people to Willamette Falls, restoring habitat, creating and providing new jobs, honoring the past and learning more about the culture of the people who were here before and those who are here today are incredible opportunities.
