Dear Robinwood Business Owner/Operator:

As the Economic Development Director for West Linn, my highest priorities are to support and enhance our existing businesses and to create more economic development opportunities in our community. My intent in reaching out to you is to let you know that I fully support the proposed water project as I am certain that it will be good for business and will provide long-lasting benefits for the community as a whole.

As you may be aware, the West Linn City Council recently approved a set of applications by the Partnership to renovate and upgrade Lake Oswego's 45-year-old water treatment plant located at 4260 Kenthorpe Way. Of particular importance for businesses in the Robinwood neighborhood is a component of the project that involves replacing the existing 24" water line that runs under Highway 43 with a new 48" water line. - ✓ Traffic will be directed to alternate driveways for businesses open during construction hours.
- ✓ Businesses will be given advance notice of construction activity.
- ✓ The construction schedule will be maintained—progressing about 50 feet per night.
- ✓ Contractors will make sure regular nighttime deliveries and business construction activities are

The Partnership will provide communication and marketing support to let customers know you are "Open for Business." There should be no impact to most businesses because all existing Hwy 43 lanes and driveways will be open during the day.

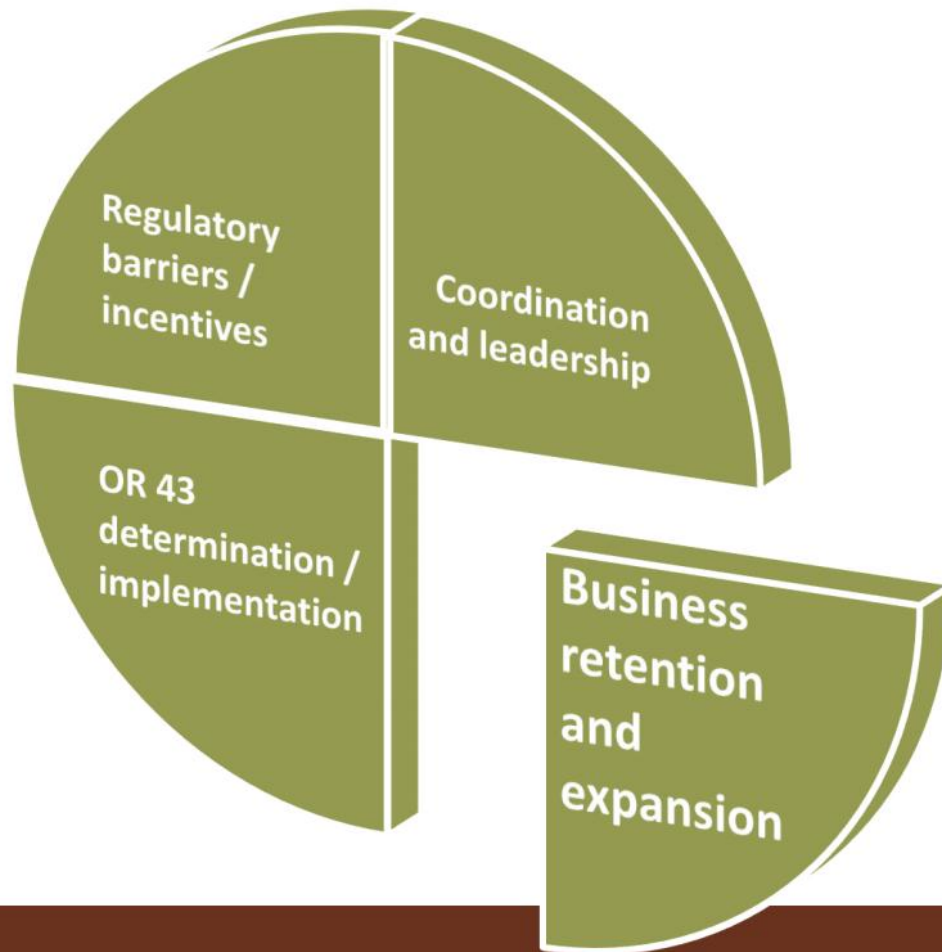

City creates LinkedIn group for local businesses

The West Linn City Council and staff have been holding meetings with local business owners to determine ways that the city can help local businesses grow and be more successful. Most recently, City Councilor Jenni Tan and Economic Development Director Chris Kerr met with Miffy Jones of Miffy's Foods (Miffy's Marvelous Muffin Mix), a home-based business in West Linn.

Just a few months ago, Miffy and her company completed a highly successful first year in business, and there are plans to scale up production and distribution in the coming year.

Originally from Australia, Miffy moved to the United States in 1995. She inherited her mother's gift for baking and has experimented with various forms of the Marvelous Muffin Mix for nearly 20 years. With a busy life that necessitated creative efficiency, Miffy began making several batches of the dry mix at a time so that she could store the extra and quickly make muffins in the morning before work.

She shared her muffins with friends and co-workers, who raved, but when they asked for the recipe, Miffy gave them a mix instead.

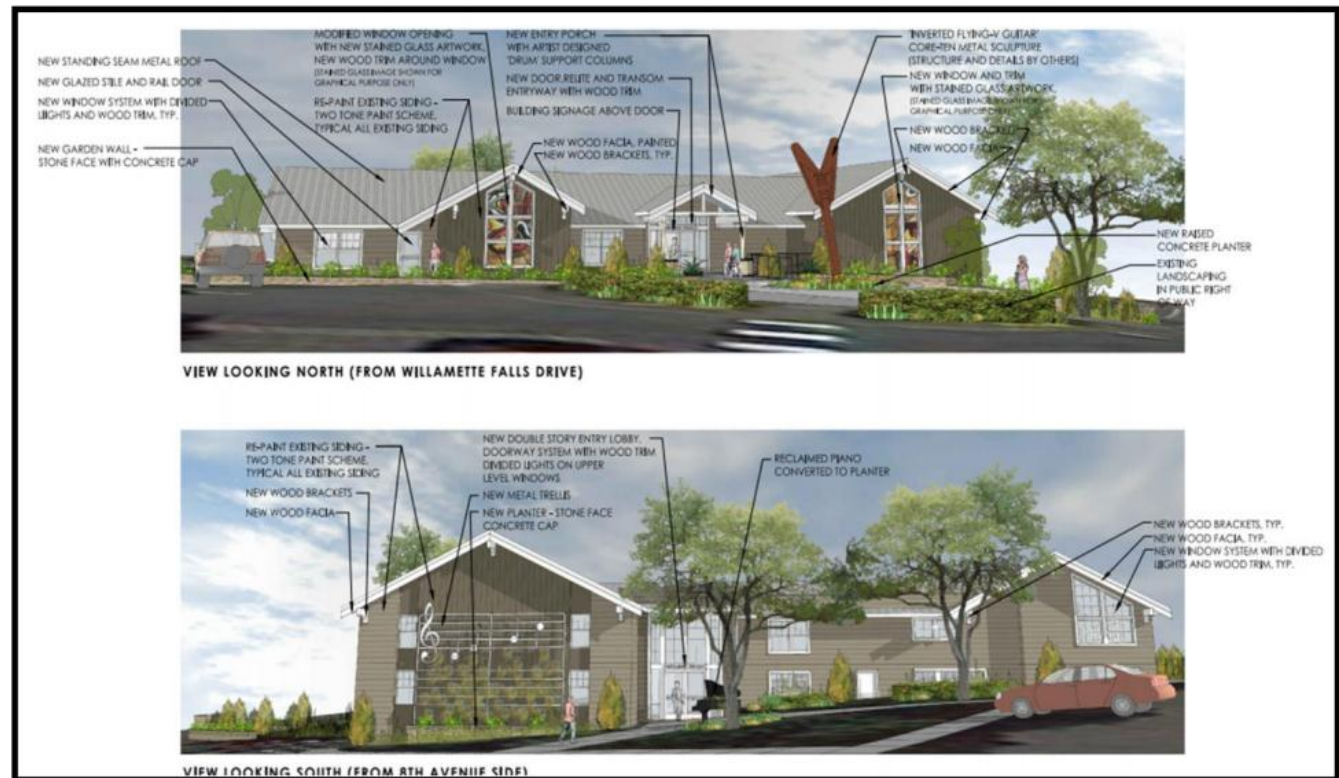

A primary focus of the Economic Development Department has been working toward the [City Council's goal](#) of modifying codes and processes to remove regulatory and financial barriers, and to incentivize positive community economic efforts. In July, I presented proposed code amendments to the Planning Commission and the City Council. Public hearings were held before the Planning Commission on August 7th and September 4th. The next hearing will be on October 2nd and the Council is expected to review the changes in November. Applying to Film in West Linn: A County-wide Process
West Linn participates in Clackamas County's Uniform Film & Media Permit Application process. To apply for a Film or Media permit in West Linn, click below to be taken to the application. For more information, visit the County's Film and Media page.

Once submitted, your application will be reviewed by City of West Linn staff. You will receive an email or phone call within 3 business days to resolve any questions, confirm your request and schedule your fee payment.

Filming in West Linn: Important Details

- Film and media operations within West Linn require a Film & Media Permit. However, activities that meet certain criteria must obtain a Special Event Permit instead. If your film or media production will use the public right of way, involve more than 300 people on City property, will occur at night, or will involve loud noises/special effects or the closure of a park, a Special Event Permit will be required. Read more about Special Event Permits below, and obtain a permit here.
- The City of West Linn requires all film and media productions to provide a Certificate of Insurance naming the City of West Linn as an additionally insured. Contact your...

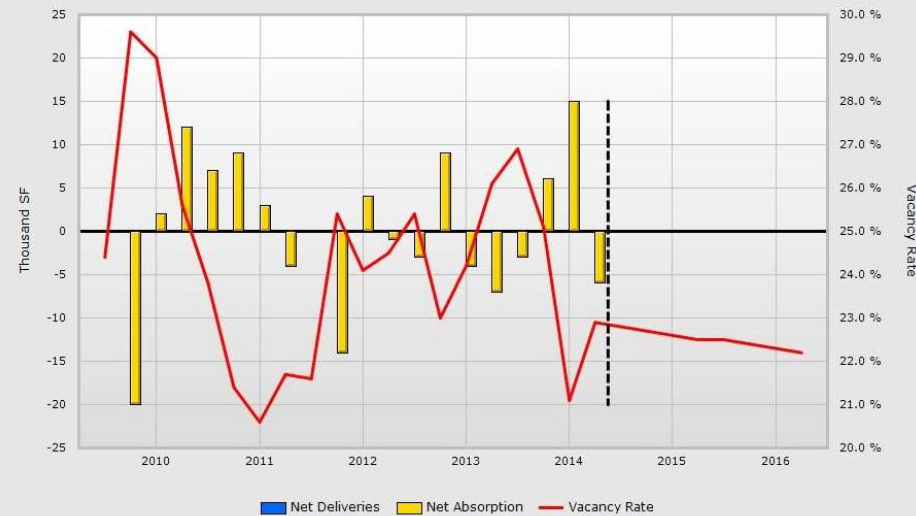

Clackamas County Tourism & Cultural Affairs Community Partnership Program

OVERVIEW:
Community Partnership Program (CPP) grants are to fund tourism-related projects in local communities. Eligible projects are those that are designed to increase tourism or tourism activity.
The legal definition of tourism per state statute and county ordinance is: "economic activity resulting from tourists." A tourist is defined as "a person who, for business or pleasure, recreation or participation in events related to the arts, heritage or culture, travels from the community in which that person is a resident to a different community that is separate, distinct from and unrelated to the person's community of residence." For a trip to qualify as tourism the person has to travel "more than 50 miles from the community of residence; or includes an overnight stay."
The funding for this program comes from Clackamas County's 6% transient room tax revenues. Therefore, increasing overnight stays is the ultimate goal.

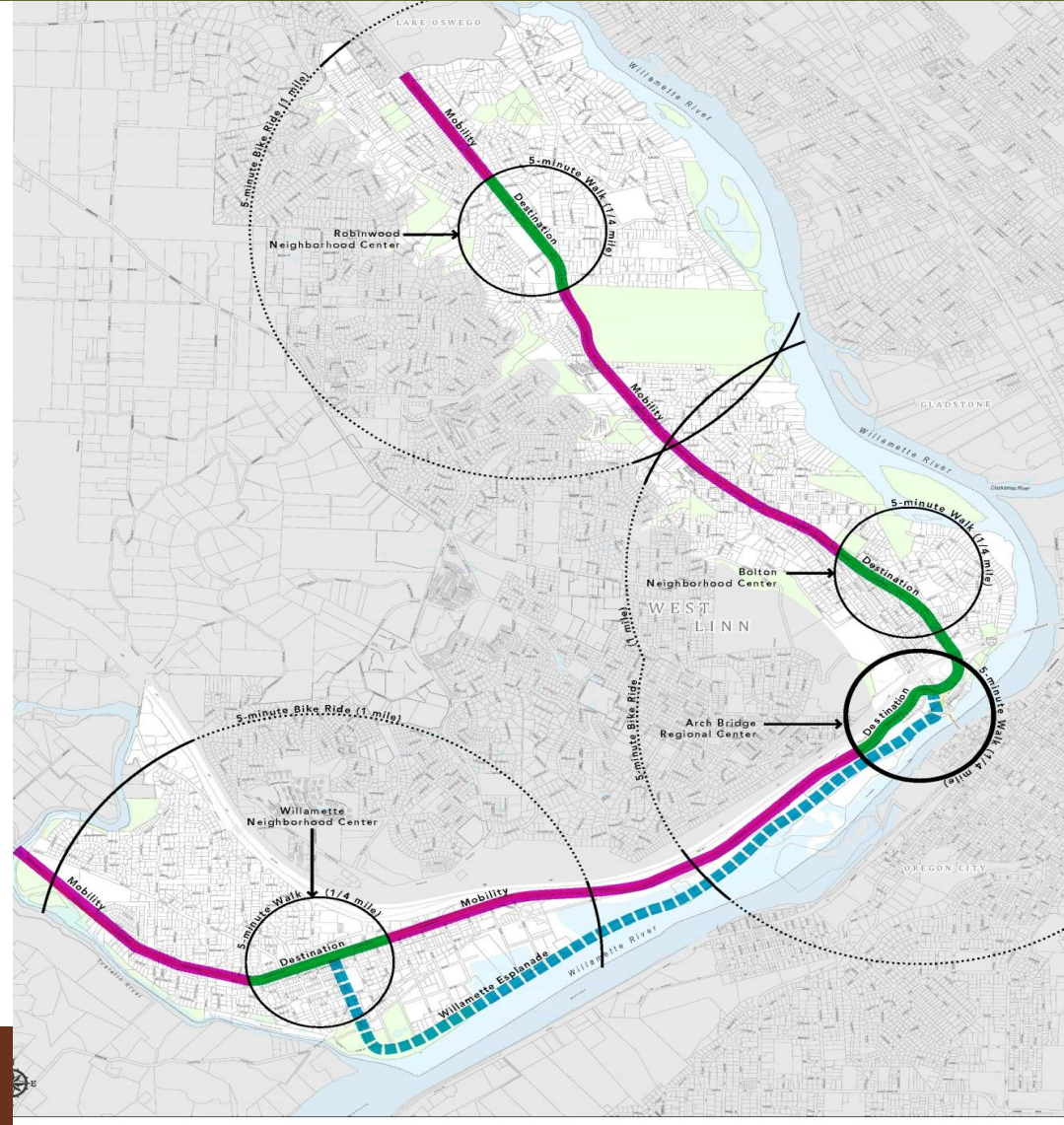


Overview of Highway 43 / WFD Vision

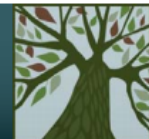

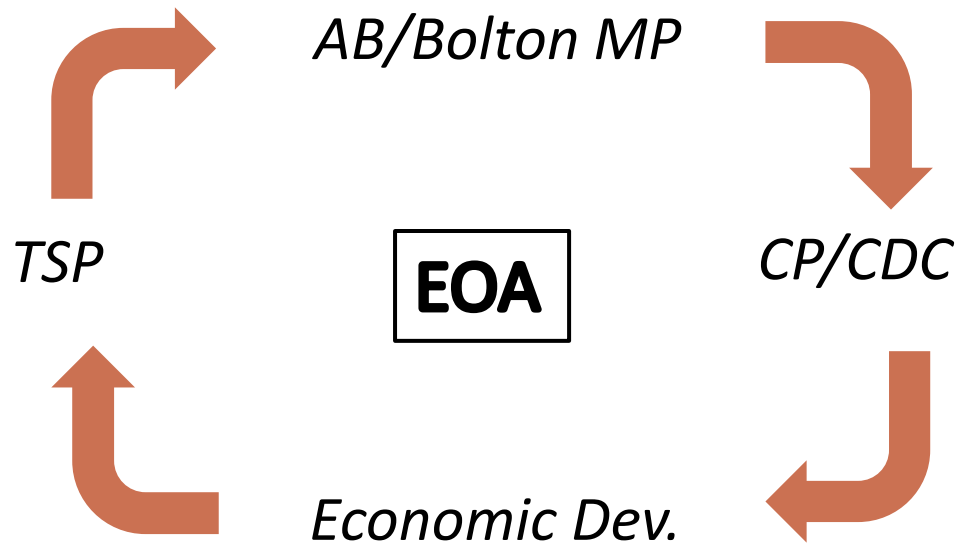

'Home base' will be located in library

With the goal of providing a "home base" for local small businesses, West Linn plans to open a new small business resource center.

The resource center will be located in a vacated office space inside the West Linn Library, and should be open by the end of the summer according to Assistant City Manager Kirsten Wyatt.

"For a couple years, we've been hearing, especially from the business community, that having a home base where you could do face-to-face business would be helpful," Wyatt said. "We had office space open in the library and realized it was the perfect place for a small business center."

Based on planning from the economic development committee, Community Development Director Chris Kerr and Library Director Holly Mercer, the center is slated to include conference space for up to 12 people, Internet Capabilities, color copying, audio-visual equipment and perhaps even notary services.
