Library Director's Comments & Report-

- Late Night at the Library- Doug discussed the event sponsored by the Library Foundation on Wednesday, September 9, 2015. We had several vendors here including; Chiros Loco, Sub Zero, Elements Massage, You & Eye and the Library Foundation gave away Voo-Doo doughnuts and pizza. We also had a live Jazz Band which received a nice tip from some customers at 503 restaurant that enjoyed the music. There were 15 volunteers that were helping with parking as well as shuttling patrons from Hammerle Park. Cowl the Owl—the City Mascot was also greeting patrons. We estimate there to be approximately 300 visitors during the event, which is a great turn out with the Back to School Night at the High School also taking place at the same time.
- Adult Programing-Trivia Night at the Library on September 24<sup>th</sup> from 7-9pm. The last Trivia Night was held at Linn City Pub and was a very successful event. We have invited Pete's Mountain Winery to the event to serve beer and wine to the patrons. The library will offer pizza by the slice (\$2.00 each) and soda's (.50 each) as well. We are very excited about this event. Upcoming Adult programs include: October- Oregon Humanities- A conversation with Alex Sager from PSU on Tuesday, October 6<sup>th</sup> at 6:30pm. In November, "Literary Corps of Discovery" The impact of Lewis and Clark and the American Imagination, presented by Doug Erickson, Library Director.
- Emergency Preparedness Fair- On September 24<sup>th</sup> the Emergency Preparedness Fair will be taking place at the Latter Day Saints Church on Rosemont Road from 4-8pm. Doug and a staff member along with a few volunteers will attend with books on emergency preparedness with mobile check out. Topic of discussion for Doug will be the benefit of the LINCC optic network to be installed in December or January.

- New Staff- Doug made the announcement of Caitrin Lenartz, Library Assistant III, she will
  be the Volunteer Coordinator. Caitrin was our Summer Intern for the Summer Reading
  Program and did a fantastic job working with staff and volunteers throughout the summer.
  The staff is very excited to have Caitrin join the library team.
- Public Computer Labs- The computers in the lab have been turned around to face the East
  wall (where the R.A.I.N. room is located). This move was done to ensure the safety of all
  patrons. This move hasn't seemed to be an issue with any of the patrons.
- Notary Training- The city would like the library to have notaries on staff. Doug, Rick, Joanna and Melanie will be attending a notary class in Bend, OR on Thursday, October 8<sup>th</sup>. This training will allow for flexibility for notary services in the community. City Hall currently offers notary services, however, they will be discontinuing this service.
- Wi-Fi Hotspots- The city will be installing new routers for better Wi-Fi services. These locations include: City Hall, Parks and the Library.
