## A note about formats



- When checking out an ebook that you will read on your computer you have several choices.
  - EPUB and PDF: read in Adobe Digital Editions
  - OverDrive READ: read in your browser (this is the simplest and easiest format but is not available for every title)

## Sign up for an Adobe ID



- To use Adobe Digital Editions you must have an Adobe ID. Click <u>here</u> to get one.
- Adobe Digital Editions and your device must be registered with the same Adobe ID.

## **Download Adobe Digital Editions**



- You must install Adobe Digital Editions on your computer.
- Click <u>here</u> to download Adobe Digital Editions.

## **Authorize computer**

- Open Adobe Digital Editions, go to the Help menu, and choose Authorize Computer.
- Enter your Adobe ID and password and click the Authorize button.

## **Placing a hold**

- If all copies of a book are checked out, you can put a hold on the book. Tap the Place Hold button.
- Enter an e-mail address where you can be notified when your hold is available. Then tap the Place a Hold button.

## **Checking out**

- When you find a book you want to check out, tap the **Borrow** button.
- If you are not already signed in to your account you will be prompted to do so.

## Downloading

- Tap the **Download** button then choose your format.
- Tap the Confirm & Download link.





## **Downloading – OverDrive READ**



- To select the OverDrive READ format click the Read button.
- The ebook will open in your browser for you to read.



## **Downloading – OverDrive READ**



- You will need to create a bookmark in your browser to access OverDrive READ books offline (i.e. when you don't have internet access).
- With the OverDrive READ book open in the browser, add a bookmark and call it something you'll remember, such as the title of the book.



## **Downloading – OverDrive READ**



- To read your OverDrive READ book offline later, go to your browser's bookmarks and tap the bookmark for your book. Enjoy!
- When an OverDrive READ title expires you will be directed to this message:

The title you are trying to view is protected and not available while signed out. Sign in to view your Bookshelf.

## **Returning OverDrive READ books early**



 On the Library2Go website click the Account link. Click the Return Title button for the book you want to return.



## **Downloading – EPUB and PDF**



• For EPUB and PDF choose **Open with** and make sure Adobe Digital Editions is the chosen software. Then click **OK**.

## **Reading ebooks**



- The title will download into Adobe Digital Editions.
- To read the ebook double-click on the cover.

## **Return an ebook early**



- You can return an ebook before the due date.
- In Adobe Digital Editions right-click the book cover and choose **Return Borrowed Item**.
- Confirm you want to return the book.



## **Delete an expired ebook**



- When a book is automatically returned on the due date you'll still see the cover in your library but you won't be able to read the book unless you check it out again.
- To delete an expired book from Adobe Digital Editions, select the cover and then tap the Delete key on the keyboard.

## **De-authorize computer**



 Note: If you want to change the account under which your computer is authorized, open Adobe Digital Editions and press Ctrl-Shift-D. Click Erase Authorization.



• Next time you launch Adobe Digital Editions, you'll need to authorize it with a different account.
