I received a notice in my Barrington Heights Homeowners Newsletter regarding the proposed I-205 trail. It was, no pun intended, quite inflammatory as it linked the recent fire in Camassia park to potential fires that might occur if the trail were to be built on our hillside.

I would like to let you know that I support the trail wholeheartedly. A trail system that connects all of West Linn would be a great legacy for you to leave with the present and future citizens of West Linn. The views from the trail would be spectacular. The homeowners of Barrington Heights do not have a right to prevent others from this hillside. This fear of a potential fire is just a ruse as I suspect the real reason is to keep "riff raff" out of this neighborhood. This hillside is not the property of a few vocal homeowners of Barrington Heights and I hope you are not bullied away from making a wise choice for the entire city of West Linn.

Along with this trail, I wish the city could provide a safe pathway or sidewalk from Barrington and Salamo Road down to Blankenship and 10th street. It is terrifying to walk down the side of the roadway with cars traveling 40 mph with only a painted stripe for separation.
