ADD: For Projects #1 and 2 from Project Summary, Santa Anita Dr. North of Horton and Santa Anita South of Horton accordingly, the following conditions will apply:

- Santa Anita Drive will be closed for construction for the period not exceeding ten (10) working days starting on Monday and ending on Friday of the following week.
- For completion of the Santa Anita construction projects earlier than ten (10) working days – the contractor will be awarded a bonus of \$2,000.00 per each calendar day.
- The contractor will be responsible for the installation and maintenance of all required street barricades.
- The City will provide street closure signs.
