Meeting of the Robinwood Neighborhood Association(RNA) called to order at 7:02pm. **Agenda** approved.

Guests and Introductions: Emily Smith, new Manager of Robinwood Starbucks February 2016 Minutes approved by voice vote, motion by Mary Hill, second by Peter Lang. Treasurer Report: Balance remains \$1366.20

Guest Speakers:

Richard Seals, COWL CFO on City Finances and Budgets – City Annual Audit finished with clean opinion, perfect score. Refinanced 2 bond issues at 2.2% saving about \$400K in interest costs and beating Fed rate increase by 2 weeks. City credit rating updated to AA+. PERS rates increase looming with potential increase of \$500K per biennium and the city budget is 60% personnel therefore this is not a good time to increase city staff. New live online dashboard at bottom of Finance web pages showing real time updates to 10 city funds. Parks maintenance fee money shown on this dashboard. Reservoir bond were backed by water rates therefore no vote was required.

John Morgan on Economic Development for West Linn – On contract to city for 6 months replacing departed Director. Works for cities up and down west coast from office in Salem. Public sector throughout career, stints as city manager, has consulted for West Linn in the past. Tasks: Working with the 7 person citizen Economic Development Committee to move process forward. Responsible for Arch Bridge project. Audit of department and staffing and codes looking for efficiency to set tone for new permanent director. Also any other projects as required. Demand drives Planning staff to focus on code administration. Help community implement community goals. Building persistent capacity to thrive. Office hours at city hall Tuesday and Wednesday. Neighborhoods Associations need to be truly representative.

Old Business: LOT Emergency Response Planning: Action requested from the City staff. Follow-up to February's questions that were not answered in the presentation by Lt. Stradley of WLPD. Neighbors are not receiving answers from COWL and LOT regarding day to day security plans and operation.
