

Robinwood Neighborhood Association of the City of West Linn Minutes January 13th, 2015

Meeting of the Robinwood Neighborhood Association(RNA) called to order at 7:00 pm.

December 2014 Minutes approved corrected, motion by Mary Hill, second by Lamont King.

Agenda amended and approved.

Treasurer Report: Balance on 01/13 is unchanged at \$899.59. Balance due to FORS+/- \$200.

Guest Speakers: Public Works Projects in Robinwood 2015 - Assistant Engineer, Erich Lais
Fifth season of sewer rehab projects to limit infiltration using lining. Approx 30,000 LF in 2015.
Size limit for lining is > 8" to 21". Smaller pipes are inspected. Water main replacement -
4500 LF of substandard mains to be replaced. Currently out to bid with construction to start
in February. Road Paving and Slurry Seal projects. Mapleton and Kenthorpe delayed a year.

Report on the City Council Goal Setting Retreat - Gail Holmes

DHM conducted 2014 City Survey - 45 questions of 300 citizen by phone plus 750 citizens via
website. Question raised regarding dispersal in city. Discussions on public testimony, delaying
council decisions to next meeting, development, water system plan - 19% increase needed
versus asking for 10%. Neighborhood Associations role discussed.

Approval, which included a 28 month construction timeline.
