Meeting Minutes

August 1st, 2012

Opening:

A. Approval of Agenda

The agenda was unanimously approved as distributed.

B. Approval of Minutes

The minutes of the previous neighborhood meetings (4-3-2011 and 6-10-2011) were distributed. Jim Farrell moved to approve the previous minutes. Merle Kovash seconded the motion. All attendees passed the motion.

D. Old Business

ISSUE #1: CC&R's

DISCUSSION: Update to previous discussion around rewriting the amendment to clarify quality of roofs requirement. It was recommended that line b. should be changed to say: **"b. Minimum manufacturers' warranty of 50 years."**

Jim Farrell presented the results of his investigation into this matter. He concluded that due to the quality and warranties of current roofing materials the neighborhood CC&R's do NOT need to be updated.

E. New Business

ISSUE #1: NEW CITY STIPEND POLICY

West Linn city has changed its policy on how grant money is distributed to neighborhood associations. Due to this new policy, the Skyline Ridge Association is expected to receive substantially less grant money from the city..

John Weinerman moved to include the Beckonridge homes in the Skye Ridge Association subject to an investigation to be presented at the next neighborhood association meeting. Bryan Gilbert seconded the motion. All attendees approved the motion.

ISSUE #3: NEIGHBORHOOD DIRECTORY IMPROVEMENTS

DISCUSSION: Ideas to improve the neighborhood directory were discussed.

- a. Including a mark.(eg. Flag) next to veterans names.
- b. Improved business directory.
- c. A list of the years people moved into the neighborhood.
- d. An optional list of who rentals versus homeowners.

ISSUE #4: JULY 4TH PICNIC CLOWN

DISCUSSION: Should we still invest in paying "Giggles the Clown" \$255 to do face painting at the July 4th picnic.

ACTION: Jim Farrell moved to NOT hire "Giggles the Clown" next year. Doddie Hecht seconded the motion. All attendees approved the motion.

ISSUE #5: JULY 4TH PICNIC – OTHER IMPROVEMENTS

DISCUSSION: We talked about ideas to improve the July 4th picnic.

- a. No reserving tables.
- b. Having teen volunteers do face painting (Tracy Gilday volunteered to donate supplies).

ISSUE #6: NEW NEIGHBORHOOD LOGO

Several new neighborhood logos were distributed to attendees. The logos had previously been made available to the neighborhood, and preference votes were tallied.

DISCUSSION: John Weinerman motioned to approve a new logo. Rich Rosales seconded the motions. All attendees approved the motion.
