### Doug Erickson, Library Director:

- Best Practices for using Drop Box: Doug briefly explained how A&C Commission will be able to utilize a universal login/password account to Drop Box to gather documents, ideas & pictures in a single location. Doug and Mel will be working on an outline to follow for public record laws & a best practices. This draft/outline will be available for the commission at the next meeting in March.
- Discussion of Current Art Installations in West Linn (Lorie Griffith): Lorie Griffith emailed a document with a list of art installation (she had researched) in West Linn to commission members (also attached to agenda). The question was asked if anyone knew where the Lion statute at the Adult Community Center came from & if it would be considered art? Another question asked was "is art located on school grounds or art installed created by children" included? Councilor Cummings also mentioned the West Linn doesn't have any memorial art for Veterans. Carrie Gilbert suggested an "I spy Art in West Linn" where it involves community members to contribute noting places & type of art they spy- in a central location possibly City Website? Citizens could contribute to what they find in West Linn.
  - Art in the Garden- McLean House- April 25, 2020- Lorie shared she (ACC) had received an invitation to have a booth at the upcoming "Art in the Garden" at the McLean House in April. It was agreed that the ACC will have a booth promoting the Art & Culture Commission. Lorie offered to work the booth. There was a question regarding a budget for the ACC for pamphlet or handouts. Council Cummings mentioned that City Council has that topic on an upcoming work session.
- Election of new Commission Chair & Co-Chair: Staff liaisons Doug Erickson & Melanie Nelson left for the vote of new chair & co-chair for the 2020 year. Carrie Gilbert was elected Chair and M.J. Steele was elected Co-Chair. (Chair in 2019 was M.J. Steele & Co-Chair was Carrie Gilbert).

- Narrow down what is "West Linn-ish"
- Americans for the Arts
- Work with a consultant
- Lake Oswego works with a different selection committee for each piece to avoid any issues
