# **Summary**City council goal 3.4 for 2021: "Request that the Sustainability Advisory Board recommend improvements to the Community Development Code."

## SAB should propose ideas for CDC or permitting process. Propose to council. Council decides on what to do. City manager implements. Goal to eliminate barriers to permitting. SAB agree on issues to address then propose to council. Can learn from other cities. Our proposals may affect other codes and rules.

- 1. building permits for electric panel of charging station, multi-family and solar
- 2. solar panels on roofs of new homes
- 3. zoning for supporting business
- 4. tree removal on new home/business development and school district
- 5. city-installed charging stations at city hall and elsewhere

- 6. parks & rec policy re water usage and pesticide and herbicide usage. Need better water policy. Low water usage and tiered pricing for heavy users pay more.
- 7. Fire prevention with landscaping.
- 8. Landscaping with more native plants or those that require less water
- 9.
