Library Update: Doug Erickson, Director of Library & Community Services:

The library may need to close a reference desk due to staff shortages. Doug reiterated that the library **will not** be going back to closing the doors to public & curbside services. The library will remain open.

 Therefore, we do not currently have an LDAC rep. The LDAC report is
