Status of Skyline Circle/Drive:

Sunset N.A and the City have made no objection to this neighborhood to joining the Bolton Neighborhood. All members at this meeting voted unanimously to accept them as part of Bolton Neighborhood Association. The BNA will confirm with the City.

Survey on the future of Oppenlander Fields:

Erich, Vice President, requested the Public Records, on behalf of the BNA, from West Linn-Wilsonville School District. The request included: the original purchase contract in 1978; was it funded by a bond generated by the school district; what was its intended use; and, currently, how does the school district intend to use the proceeds from the sale and will proceeds pay for existing school district bonds.

Kelly Douglas, Exec. Assistant to the Superintendent & School Board, responded: Property was not purchased using bond funds (price): \$45,602.40. It has been "land banked" for a possible new school location. The Long Range Planning Committee deemed it surplus and the School Board directed it for sale. For now, the proceeds will be "land banked" in the School District account and available for future land purchase. For more information: go to Hot Topics

Status of the process for hiring a new police chief: Rachel Tillman, representing Bolton N.A., as member of the panel, reported on the process and discussion with the 3 finalists: Current acting Police Chief Peter Mahuna, Port of Portland Police Captain Cory Chase, and Department of Public Safety Standards and Training Leadership Program Coordinator Terry Moss. The panel questioned each candidate their approaches to community engagement and answer questions about their plans for leading the police department. Rachel said she was pleased with the in-depth process of the questions and responses.

Request for top 5 emergency preparedness/recovery concerns: Attendees List:

Communication. Access to emergency information.

- Who to call nearby to ask for assistance.
- Roads access. The ability to get around.
- Available resources of temporary housing, water and water purification systems, power, and safety/first aid stations.
- A central information bank of neighborhood resident's personal resources that are kept confidential by the Emergency Management.
- Coordinator and released only in an emergency. I.e. chainsaws, those with generators, charging stations, emergency oxygen, etc.
