Updates:

• Action items to regulate Willamette River noise pollution: Mike Arthur and neighbors:

Should BNA be the plaintiff in a nuisance lawsuit?

Mike Arthur and 6 neighbors on the waterfront gave testimony of the on-going destructive noise levels from several individuals at Meldrum Bar Park operating performance 2 stroke Jetski that continue for hours at noise levels much higher than the temporary 75 decibel limit put in place by the Oregon Marine Board. The individuals have continued this behavior in spite of conversations with West Linn, Gladstone police and Clackamas County Sheriff Dept. The difficulty is for police/sheriff to catch them in the act since the activity is stopped when law enforcement arrives. Additionally, a noise meter must be properly calibrated against background noise and taken from the shore. The Bolton neighbors have asked the BNA to become the plaintiff against nuisance jetskis as the best option to move forward at this time. It was noted that the cost of an attorney and the nuisance lawsuit will not be the responsibility of the BNA, and will be secured before a lawsuit moves forward.

A motion was brought forward, after the 3rd amendment vote, for the BNA to become plaintiff against nuisance Jets: Vote Ayes: 15; 1 Abstain:

Final 3rd Amended Motion: The BNA will assign a committee to seek legal advice from an attorney to explore signing onto a nuisance lawsuit against the 2 stroke jetski operators performing aerial maneuvers that cause ongoing nuisance noise levels. Funding will come from private funds and be secured before any lawsuit moves forward. The committee and officers report to the neighborhood association for a vote on whether to proceed with a lawsuit.
