Updates:

- **Update Development corner of Hood and Burns Street:** There will be parking on Burns Street, west bound, adjacent to the building no parking opposite side. City Traffic Engineer planning to evaluate traffic issues at intersection of Burns St. and Cascade St. to ensure safe traffic flow.
- Pumpkin "Carved" Contest & Music "Knotty Sangria" October 22nd, 1:00 pm 3:30 pm, Hammerle Park: Bob McCarthy: confirm reservation at Hammerle. Volunteers: Jenn Buman, Pat Hogan, Lisa Wolff, Amanda Brookshire, and officers to: 1. Request donations from local businesses in Bolton for gifts and to advertise their businesses Jenn Buman, Pat Hogan. 2. Find small pumpkins to give away. 3. ASAP get out the word for our fun holiday gathering through social media and flyers posted. 4. Planning for day of event & set-up.
- **Bolton Neighborhood Road Signs:** Update -Vince Miles confirmed, with the city, the size of the sign, 2 ft x 3 ft, consistent with all neighborhood signs in the city City will install. The 2 sites agreed by attendees are: Pimlico Drive and Skyline Drive.
- **Professional Jet-Ski Noise on the Willamette River:** Christian Selleron gave an update: A "cease and desist letter" has been served to the individual with the un-muffled, 2-stroke jet-ski creating excessive noise at Meldrum Bar between West Linn and Gladstone. Christian reported that the individual has not been seen for a month on the river. If the individual returns next year the attorney hired will take the next step.

• **Encampment:** The City is considering the 4100 Willamette Falls Drive currently leased on a year-to-year basis used by Public Works. The City is discussing the matter with PGE.

- **Speeding Jolie Point Road:** Daniel Hayes updated his efforts to address the dangerous problem of excess speeding with the city & police department.
 - He canvassed neighbors with a questionnaire: the gathered comments revealed anger toward the city for not doing enough to help ensure drivers comply with posted speed limits.
 - According to Daniel, the WL Police Dept. had indicated they would do some patrolling of the area.
 - As of this date, the Records line shows no records.
 - Possible engineer upgrades to address and slow down traffic.
 - Engineering City Planning no plans for modification at this time.
 - Daniel is suggesting the city apply for **Safe Streets and Roads for All (SS4A) Grant Program https://www.transportation.gov/grants/SS4A** as a means for funding to improve the safety on Jolie Point as well as other dangerous city streets.
 - Daniel plans to attend the next Traffic Safety Committee Meeting.
 - Amanda Brookshire suggested a survey flyer to neighbors for an assessment of how people feel about the safety and walk ability of the Bolton neighborhood using use our yearly post card for broad reach in Bolton.
- Nominations for Officers for November Vote: President: Patrick Hogan, Doug Buman; Vice President: Vince Miles; Secretary: Amanda Brookshire; Treasurer: Alfred Brown
- **Communication Coordinator:** Jan McCarthy noted that this position is needed to assist officers and the association for broader outreach using social media and other means. All agreed at the meeting for this position/assistance. Lisa Wolff has volunteered to fill this position with the agreement of current participants.
