Subject: Contract Award for the Concrete Street Improvement Project (PW-14-09)

### **Purpose**

Provide Council approval for the 2014 Concrete Street Improvement Project.

### Question(s) for Council:

Should the City spend capital funds on concrete street road improvements?

### **Public Hearing Required:**

None required.

### **Background & Discussion:**

The Concrete Street Improvement Project provides for concrete pavement reconstruction, drainage improvements and water main replacement along previously identified streets throughout the City that have failed beyond simple asphalt repair. Concrete provides a long lasting replacement for failed existing low volume local roads.

Streets in this year's concrete street project include:

Geer St.

Beam St.

Tompkins St. (Failing St. to End)

Century Lane

The project was advertised and bid in accordance with the West Linn Local Contracting Rules. A bid opening was held on June 4<sup>th</sup>, 2014 at 2:30 PM with a total of 4 bids. Following the competitive bid selection process it was determined and verified with the City Attorney that, in accordance with Oregon Revised Statute 279C.370, the lowest bidder was non-responsive and could not be considered for award. The lowest responsive, responsible bidder is Brown Contracting Inc. at \$648,595 who had positive reference checks.

# **Budget Impact:**

\$648,595 to the Streets, Environmental, and Water funds.

### **Council Options:**

1. Award the contract to the lowest responsive and responsible bidder, Brown Contracting.

2. Cancel the bid solicitation and retain the capital funds.

### **Staff Recommendation:**

Approve the contract with Brown Contracting.

### **Purpose**

### **Background & Discussion**

At the time of deadline for submission of the Agenda Report for this project the contractor selection and vetting process had not yet been completed.

Following the competitive bid selection process it was determined and verified with the City Attorney that, in accordance with Oregon Revised Statute 279C.370, the lowest bidder was non-responsive and could not be considered for award. The lowest responsive, responsible bidder is Brown Contracting Inc. at \$648,595 who had positive reference checks.
