2018 GO Bond Updates

On May 15, 2018, the voters of West Linn approved Ballot Measure 3-527 authorizing the issuance of up to \$20 million in general obligation bonds to improve roads, parks, and city facilities. Here is an update on some of the GO bond Projects that have been in the works.

Historic Willamette Falls Drive



One of the most exciting GO Bond projects taking place in early 2020 is the redesign of Historic Willamette Falls Drive from 10th Street to 16th Street. The purpose of the project is to enhance the "Main Street" character of Willamette Falls Drive by refocusing the space to a pedestrian scale, while also accommodating biking, parking, and vehicle travel. The design will feature much wider 12-foot minimum width sidewalks, family-friendly bike facilities separated from vehicle traffic, improved decorative street lighting, enhanced landscaping, and safer intersections that accommodate handicap accessibility.

At the time of publication, a construction contract has not yet been awarded, so exact construction dates are not yet available. However, utility work in advance of construction will begin this winter. Demolition of existing landscape medians and curbs is projected to begin in January of 2020, with construction proposed to be significantly complete in June 2020. Utility, lighting, and landscaping work will continue throughout the 2020 calendar year based on weather, contractor availability, and lead times on equipment and materials. Willamette Falls Drive and all businesses will remain open during construction – be sure to shop local and show your support for our Willamette businesses!

Sunset Fire Hall



Renovations to this heavily-utilized building called for updating restrooms, removal of lead paint, and new exterior paint. With minimal disruption to the facility's busy schedule of classes and events, all exterior renovations were completed on time and under budget. The fresh paint, wood trim accents, and necessary replacement of rotting wood give this building a new, crisp appearance. Interior renovations, which include updating restrooms and removal of lead paint, are expected to begin soon.

From the City Manager:

The City Manager's Role in Local Government

Recently I was invited to the Rosemont Summit Neighborhood Association (RSNA) to speak about the role of a city manager in local government. RSNA is doing a series called "Getting to Know West Linn City Government" and was interested in hearing about the history of the city manager in local government.

Professional city management is rooted in onset of the industrial age. In the late 1880's, new inventions and technology created new classes of super wealth in Europe and the United States. By the early 1900's, Chicago became the focal point of the political battle between labor and capital in the Gilded Age. The revelation of scandalous working conditions in the Union Stock Yards caused endless friction between business titans and labor forces. Political machines became the way of the working class to win the economic struggle, but they also gave rise to political patronage.

Government Should Run Like a Business

Industrialization led to new forms of work organization, development of the factory system, and formation of business corporations funded by issuance of stock (shareholders), governed by a board of directors and administered by a chief executive officer. In 1908, Staunton, Virginia appointed the first "general manager" to professionally oversee the administrative functions of the municipal government. In 1912, Sumter, South Carolina adopted the first council-manager form of government.

In 1914, the first meeting of the new International City Manager's Association (ICMA) was held with 32 participating local governments in the United States and Canada which had adopted the council-manager plan. Today there are over 3,000 "council-manager" local governments officially recognized by ICMA, including West Linn, with thousands more that hire city managers/administrators, but are not officially recognized.

Professional city managers and ICMA members are expected to follow a 12-Tenet Code of Ethics which includes maintaining the highest ideals of honor and integrity, being dedicated to the concepts of effective and democratic local government, and refraining from engaging in political activities. According to Moody's Bond Rating Service, two-thirds of AAA rated (the highest municipal bond rating) cities have the council-manager plan in place.

City Manager Position in West Linn

The position and powers of the West Linn City Manager are established and spelled out in the West Linn City Charter. The City Council is the legislative body of the City. The Council sets goals for the City, approves the budget, and determines the policy direction of the City. The City Manager is the chief administrative officer and carries out the policies, programs, and projects on behalf of City Council with the budget they approve. The simplest distinction between the two is that the City Council sets policy and the City Manager carries it out.

Prepare for Winter Road Conditions

Winter is upon us and the changing of the season brings the possibility of hazardous road conditions. The Public Works Department's Snow and Ice Removal Plan places equipment on designated principal routes throughout the City. These routes are designated to enable the accessibility of emergency vehicles, school buses, and residents to all major areas of the City. The Public Works Department, along with the West Linn Police Department, determines the condition of roadways and whether or not they should be closed. In a severe storm, only primary routes are maintained. When the storm subsides, and conditions are safe for sanding crews, route maintenance is expanded to additional roadways.

Several of the City's streets with steep grades are especially hazardous, and will likely be closed when snow and ice accumulate. They are:

- Marylhurst Drive from Hillcrest to Lower Midhill
- Hidden Springs from Bluegrass Way to Cottonwood Court
 - Pimlico Drive from Palomino Way to Willamette Drive
 - Summit Street from Rosemont Road to Skyline
 - 12th Street from Tualatin Avenue to Volpp Street
 - Skye Parkway from Troon Drive to Hillside Drive

When these roads are closed, motorists are advised to use Rosemont Road (within City limits) to Summit Street to Cornwall to Sunset Avenue. Another route is Rosemont Road (within City limits) to Salamo Road to 10th Street. Pimlico Drive will be included as an access route unless conditions become too hazardous for travel. These routes will be a priority for sanding and plowing to assure available routes from the upper areas to the lower areas of the City and freeway.

The City's main goal is to maintain streets for your safe commute during hazardous weather conditions, but snow tires and/or chains may still be needed to safely navigate City streets. Savanna Oaks Neighborhood Association

Savanna Oaks NA conducted the following business during the last quarter:

- Firewise certificate renewal was approved for SONA which means that we met the requirements to help keep us safe from wildfires.
- Scientists working on their Masters and PhD theses visited the White Oak Savanna and documented the various species of Gall wasps which lay eggs in the galls which they induce on the oak trees. This is a symbiotic relationship between the wasps and trees and does no harm to the Oaks.
- SONA passed a resolution stating that any Natural Play Area constructed in the park should be compatible with a natural wildlife habitat.

 Plans were made for a group of Adult Girl Scouts to visit the White Oak Savanna in October.
