Be ready for the next season in our beautiful city by planning ahead and being prepared.

City crews are prepared and ready, with on-call staff available 24/7 for emergency operations.

We are actively monitoring weather reports and meeting with weather experts and emergency management personnel on upcoming storm events.

Our de-icing, plowing and sanding equipment is at the ready at our Public Works Operations Yard:

- 4 trucks with plows and sanders
- 2 pickups with plows and de-icer tanks
- 1 pickup with plow and sander
- Front-end Loader with Ice Breaker
- 8,000 gallons of de-icer
- 400 tons of sanding rock

During weather events, staff patrol the City making safety determinations about which roads to close. Please follow all posted signage.

PLANNING FOR WINTER WEATHER

Get ready for winter weather! Our City crews take regular maintenance and preparedness measures to ensure we are always ready and ask that you do the same to prepare yourselves and your home to help ride out any storms this winter as comfortably as possible. Our experienced Public Works crews will be out deicing and plowing as necessary. If you have to travel during inclement weather, check out our inclement weather driving routes to find the safest routes and know where to expect closures. Please obey all posted closures. We ask that community members please limit driving as much as possible or consider staying safely at home when road conditions are expected to be icy, snowy or hazardous.

The City of West Linn, the West Linn Police Department and the West Linn/Wilsonville School District use FlashAlert for emergency notifications.



Snow Route

Winter is coming to West Linn (though we hope this season will have a better ending than a certain TV series). Several of the City's streets with steep grades are especially hazardous and may be closed when snow and ice accumulate.

THEY ARE:

- Marylhurst Drive from Hillcrest to Lower Midhill
- Hidden Springs Road from Bluegrass Way to Cottonwood Court
- Pimlico Drive from Palomino Way to Willamette Drive
- Summit Street from Rosemont Road to Skyline
- 12th Street from Tualatin Avenue to Volpp Street
- Skye Parkway from Troon Drive to Hillside Drive

When these roads are closed, please use Rosemont Road (within City limits) to Summit Street, to Cornwall, to Sunset Avenue. Another route is Rosemont Road (within City limits) to Salamo Road, to 10th Street. Pimlico Drive will be included as an access route unless conditions become too hazardous for travel. These streets will have a priority for sanding and plowing to ensure clear routes from the upper areas to the lower areas of the City and freeway. Salamo Road and Sunset Avenue may have short-term closures due to spun-out vehicles.

Hello, fellow West Linnians!

I hope you all have had a wonderful summer in the City and that you enjoyed some of the City's summer programming, whether it be catching a movie at Mary S. Young, listening to music at Tanner Creek or frequenting the Wednesdays in Willamette Summer Street Market among many other opportunities. I am writing to keep you updated on what the City Council has been working on. This first edition of the Mayor's Message recaps our summer activities over the last few months.

HERE ARE A FEW HIGHLIGHTS:

Council continues exploring the idea of a community recreation center. Expect more communication on that from the City in the future as we work towards determining whether residents are interested in this opportunity. Sign up at **westlinnoregon.gov**/e-news to stay involved.

The City Council passed a balanced two-year budget in June. The budget continues the provision of essential city services, maintains staffing levels and provides us with a guiding document for capital projects.

City Council adopted a public camping time, place and manner ordinance that regulates where houseless individuals can and cannot camp on City property to comply with a new law that required cities to remove camping bans and instead allowed cities to create "objectively reasonable" regulations. A community task force is nearing the end of their work to recommend a designated space for tent and vehicle camping on City property.

In late June, \$5 million was allocated to West Linn by the Legislature for our Abernethy Bridge waterline replacement project that will keep drinking water flowing to West Linn for many decades to come.

ODOT then announced in their finance plan that tolling collection on the Tualatin River Bridge (near the Stafford Road exit on I-205) was delayed indefinitely, meaning that West Linn residents have one less toll zone to worry about for now. As a trade off, this means that the third lane on 205 near West Linn won't be constructed as the state had planned. We continue to fight for West Linn's interests with ODOT, the Oregon Transportation Commission, and state lawmakers with jurisdiction over these issues.

An Accessory Dwelling Unit (ADU) code package was adopted to make building ADUs more accessible and equitable for all. This will allow for more diverse and generational living spaces if property owners choose to build them.

Work continues on developing the Waterfront Master Plan and Highway 43 Land Use and Neighborhood Connectivity Plan (soon to be kicked off).

WEST LINN WATERFRONT PROJECT

City Council wants to hear from you! We're asking residents to collaborate in the development of a community-driven plan for the Willamette River waterfront area (stretching from the Arch Bridge to the Willamette Neighborhood). Ultimately, the plan will create a vision for future land uses and activities based on current community values and aspirations. It will help shape how West Linn would like to use and interact with this underutilized area for future generations.

The Plan's public process includes:

A COMMUNITY-DRIVEN VISION FOR THE WA-TERFRONT AREA

Establishing the community vision for the Waterfront Area and each development district will inform the rest of the project, and this is where we need your help! What do YOU want to see here? The community visioning efforts will shape the project using four guiding principles: improved river access, preservation of historic character, increased reinvestment opportunities, and transportation improvements. These guiding principles were developed from previous outreach and planning efforts, particularly around the history of the site, and from tribal engagement conducted as part of the Willamette Falls stakeholder engagement process. We're planning to connect with you through an extensive, long-haul outreach campaign featuring tabling events around town, surveys, town halls, youth involvement, and more.

FUTURE STEPS

Consultants will develop action plans for each district that identify where early momentum can be created to support the rest of the Plan. The action plan will identify emerging issues that could impact the project and develop creative ways that the redevelopment plan could respond to these issues or future issues.

Based on this public input process, the City will develop a proposed zoning and redevelopment plan for the different project districts that meets community intent. Feedback from all stakeholders and property owners is essential to determine future opportunities in the Historic City Hall District and Industrial Heritage Districts. Consultants will then develop action plans for each district that identify where early momentum can be created to support the rest of the community's plan. These will identify emerging issues that could impact the project and develop creative ways that the plan could respond to these issues or future issues.

HIGHWAY 43 LAND USE & NEIGHBORHOOD CONNECTIVITY PLAN

We need your input! We're teaming up with residents like you to develop a new, future-focused vision for the Highway 43 corridor (stretching along both sides of Hwy 43 from the boundary of Lake Oswego all the way to I-205). Although this area serves as a critical north/south transportation link in the Portland Metro region, it doesn't add much to the livability of West Linn or the vitality of our economy. Not yet, anyway!

What new opportunities for residents to live, work, and play here would YOU like to see? Safe crossing points on Willamette Drive? Small businesses that meet neighborhood needs like restaurants and shopping? Parks and green spaces? Pedestrian-friendly plazas with walkable connections to goods and services as well as other neighborhoods? A safe place for teens to hang out? The City needs your help exploring mixeduse zoning to re-energize the corridor with a vibrant mix of housing types, workplaces, shops, and parks for people of all ages, incomes, and abilities. We'll be asking for your ideas through an extensive, long-haul outreach campaign featuring tabling events around town, surveys, town halls, youth involvement, and more.

GROWING BUSINESS SUPPORT IN WEST LINN

In Spring 2022, the City of West Linn implemented a new Business Support & Economic Development program. The program supports our small business community, economic development projects in our Community Development department and some Tourism efforts. We developed three \$75,000 grant programs for small businesses including a façade improvement and technical assistance grant. One façade grant awardee shared: *"I can't thank the city enough for what a huge improvement the grant work has done to improve the beauty of our area!"* The program collaborates with local partners, colleagues and the Economic Development Committee to thoughtfully grow our economic land-scape and make it easier to do business here. We hope to continue to find more grant resources and are currently developing a new business coalition to support the small businesses located on Willamette Drive / Hwy 43.

Another key component in local business outreach is the strong partnerships the City has cultivated with the West Linn Chamber of Commerce (westlinnchamber.org), Historic Willamette Main Street (historicwillamette.com) and the Lake Oswego & West Linn Business Recovery Center (wanderwillamette.com). These purposeful connections create a synergy among the community and bring events, tourism, business education, resources, marketing and support to a whole new level! Partnerships like these amplify the growth, vitality and possibilities West Linn has to offer to all businesses!



Certificate of Achievement for Excellence in Financial Reporting Award

Finance Audit Award!

The City of West Linn received the Certificate of Achievement for Excellence in Financial Reporting award for our Annual Comprehensive Financial Report for the fiscal year ended June 30, 2022. This is the 13th year in a row we have received this prestigious national award.

The Certificate of Achievement is the highest form of recognition in the area of governmental accounting and financial reporting, and its attainment represents a significant accomplishment by a government and its management.

POLICE REVIEW AND RECOMMEND COMMITTEE

In July 2020, City Council convened a Task Force of community members to make recommendations on how best to provide community involvement in police oversight. The goal was and is to improve transparency, accountability, inclusivity, and public trust in the West Linn Police Department. In December 2022, based on the initial Task Force's recommendations, City Council established a permanent, formal police oversight body called the Police Review & Recommend Committee.

This Committee will provide independent oversight of police complaints, investigations, and policy reforms. Members will undergo training and meet as-needed to review issues, plus hold a minimum of two annual public meetings to review and make recommendations on policy, trends, complaints, reports and progress toward reform goals. More details regarding how this Committee will operate are provided in Ordinance 1741.

The City of West Linn is committed to principles of transparency and inclusivity.

We take complaints of employee misconduct very seriously. An online reporting tool is available for your convenience if you need to make a complaint about a police officer or other City employee. This complaint tracking system is hosted by a third-party complaint hotline provider, EthicsPoint. All complaints are initially routed to the City Manager and Human Resources. If the complaint is about either of those people, the complaint is routed to the City's employment attorney office. Please visit tinyurl.com/ WLEthicsPoint

In 2011, she served on the Highway 43/Willamette Falls Drive Vision Advisory Committee. Since retiring in 2022, she has more time to give back to the community and was appointed to the Citizen's Budget Committee. In August 2023, she was appointed as interim City Councilor. She looks forward to collaborating with the Council, staff, and citizens to continue building a community where we are proud to live and serve. Neighborhood associations (NAs) are one of the recognized channels for community participation in West Linn, and they're different from Homeowners Associations. West Linn's eleven NAs offer an opportunity for the community to participate in decision-making in the geographic area in which they live. These volunteer organiza-

tions bring neighbors together to improve the livability of West Linn's neighborhoods. Participation in an NA is voluntary and open to all community members who live, own property, or a business within its boundary.

NAs may also play an important role in building a sense of community within their geographic area. This involves building positive relationships amongst neighbors and working together for the common good of the neighborhood. Holding block parties, ivy removals, cleanups, and helping elderly or disabled residents are all possible parts of this role.

Neighborhood Associations are one of the best ways for the public to organize around local issues, stay informed of City business, grow strong neighborhood connections, and have a voice in local government. City staff, Council, and the entire West Linn community are grateful for the donated labor of participants, which ultimately benefits everyone.
