

## Welcome to the first quarterly edition of the West Linn Update!

The West Linn City Council set a goal for 2015 to transition the city newsletter to a quarterly publication, with enhanced content and neighborhood-specific news. This change saves the city approximately \$10,000 per year. You'll receive this newsletter in your March, June, September and December city services bills. ## State of the West Linn water system

This edition of the West Linn Update focuses on our water system - from source to tap. Take a look at these pictures to better understand where your water comes from and why the city's investment in our water system is one of our top priorities to ensure public health, public safety, and economic prosperity.



West Linn's water intake is on the Clackamas River. This state-of-the-art raw water intake withdraws water from the river and pumps it almost 2,000 ft. in distance and 300 ft. in elevation to the water treatment facility in Oregon City. The cities of West Linn and Oregon City have joint ownership of the South Fork Water Board.

Prior to 1915, both Oregon City and West Linn's drinking water came from the Willamette River. As a consequence of a serious outbreak of typhoid in 1913, the Oregon City Commission formed the "Pure Mountain Water League" and directed it to find a new source of drinking water. The League identified the South Fork of the Clackamas River. In March of that year the Oregon City Commission accepted West Linn's request for one-third share in the project. As a result, representatives from both Cities were selected and the South Fork Water Board was created. In 1996, the City of West Linn purchased the remaining ownership to obtain equal representation on the Board.









After treatment in Oregon City, West Linn's water flows through a pipe that hangs below the I-205 bridge. In 2007, a major break occurred in this water line. In cases of emergency on the I-205 bridge, West Linn relies on a redundant, independent water supply from Lake Oswego/Tigard (LOT). LOT's water is piped from the Clackamas River, under the Willamette River.

West Linn currently has a backlog of \$4 million in deferred maintenance projects for the water system. To address this backlog, the citizenled Utility Advisory Board has recommended 18 percent water rate increases for maintenance projects. However, West Linn's charter limits annual increases to five percent per year without a vote. This results in a work cycle that responds to pipe breaks and leaks, rather than preventing them before they occur.





West Linn currently has 11.25 miles of asbestos-coated, or AC, pipe. When AC pipes break, the entire line must be replaced. The goal is to remove all AC pipe from the West Linn system.

West Linn's water is pumped from the I-205 transmission line to the main water storage facility, the Bolton Reservoir, located off of Skyline Drive, across from Wilderness Park. The Bolton Reservoir was built in 1915. At the February 16 meeting, the West Linn City Council authorized the construction of a new, seismically secure reservoir at the same location. Design work has started on the new reservoir, with construction scheduled to begin mid-2016.





A reliable water system is critical for public health and public safety. Adequate water pressure, especially in the hot summer months, is important to ensure that water is available in a fire emergency. Recently, the construction of the Bland Pump Station increased redundancy for the whole water system and increased the capacity needed in the Rosemont pressure zone.





The City of West Linn received \$5 million from the Lake Oswego/Tigard Water Partnership (LOT). This money will be spent on West Linn's Bolton Reservoir project, and an additional \$700,000 in LOT projects also directly benefit the West Linn water system. In addition, LOT is providing \$775,000 in street maintenance projects.

Richard Seals, the City of West Linn Chief Financial Officer, estimates that if the City had to borrow money to fund these water projects, rates would have to increase by an estimated 19 percent of the

water portion (or \$3.88) of your City Services bill in order to pay back the borrowing. Below is an overview of Richard's calculations; email Richard at rseals@westlinnoregon.gov if you have any questions about these estimates.

## WEST LINN WATER PROJECTS

# Projected Savings to West Linn Water Rates:

- \$5.7 million = Amount of additional bonding needed if not for LOT's contribution
- 20 years = Term of financing
- 4% = Estimated annual interest rate
- \$419,000 = Estimated annual debt service payment for principal and interest over the term of the financing
- 9,000 = approximate number of utility accounts (businesses and residences)
- \$46.56 = Estimated annual amount saved on average per utility account
- \$3.88 = Estimated monthly amount saved on average per utility account (or 18.97% of the 1/1/16 water portion of the average bills)

Water Pipe Insurance Policies Are Not Affiliated with the City of West Linn

The City of West Linn wants to remind our customers that offers for water service line insurance are not associated with the city water system, nor does the city have any connection with any such insurance carrier.

On occasion, private companies send letters to residents offering a repair plan for the water service line extending from the resident's house to the water distribution pipeline, which usually runs in the street in front of the house.

These letters state that the line extending from the house to the water meter is the homeowner's responsibility. This means that if the home service line experiences a crack or break, the resident is responsible for all associated costs. While this is in fact true, some sales literature from such insurance company has confused some residents, making them feel that they are required to have an insurance policy that is separate from their homeowner's policy to cover any water utility line damage.
