January 11, 2018

Review of Agenda

Moved election of officers to later in agenda after additional committee members arrive.

Minutes

Correct scriveners error of spelling of Stearn to Sterns, Ray to Rae, Rachael "will talk to" instead of "talked to" in item so interest and OCB discussion add "12th they," to "testimony on this will". Shannen Knight moved to accept minutes with changes, Russel Williams seconded; approved unanimously

Old Business

Mixed Use Task Force:

Shannen Knight is now the Chair and Jim O'Toole is Vice Chair, first meeting reviewed the binder. Shannen Knight discussed the Task Force has requested the Council to add David Lawrence to the task force as he has a lot of background knowledge, part of the group that created the mixed use zoning thirteen years ago. Believe an odd number of participants is better than an even. If the Council does not approve Gail Holmes would be willing to step off as a Willamette Neighborhood Association member and have David take her place.

Waterfront Project/WLP Mill Update:

John Morgan stated the project has been waiting to hear from the property owners about their intentions. The owners now saying they will not have any news until March due to the financial issues. They are not preempting the idea if someone want to use the Mill and not removing the core items. They are mothballing and wrapping some of the machines and rolls; some sensitive items covered in heating pads. Forty-seven employees still working to work with the mothballing and will not be laid off in the near future. The owners are reemphasizing their commitment to the redevelopment of Mill A and west end of island sites. Now we have a dilemma on how to proceed with master planning. Plan A is assumption it is there other than the buildings they might reuse and Plan B is to look at what happens if not. Public open house late March that focuses on the transportation options and land use patterns. We are taking the lead and laying ideas on the table; they will continue to work with us. Is there any interest from Council into discussing any other kinds of pressure to decide? One reason to move ahead is to provide leadership to the Mill owners and framework of thinking. We used Leland Consulting early on these land to evaluate the market realty, we will continue to work with them and these land use alternatives will have a financial analysis attached to them. The mill area now looks dead and they is a strong sense that everyone understands the redevelopment potential.

Other player is PGE that owns all the land other than the upland. PGE has recommitted to the Sullivan Plant and honor its heritage and take seriously the fish passage responsibility. They are trying to figure out what to do and we have invited them to participate with us. PGE has a strong mission element that is community based, the new community outreach director Brooke Brookland. We have two absolutes to bring to table; infrastructure that we need to finance and put in that relates to circulation parking; and the other is zoning. To pursue any kind of redevelopment there has to be city approval of an infrastructure plan and zoning.

Question on whether Stern wants to be involved or not? Deep engagement, very interested but not willing to commit right now. Here is a perfect example of where a development agreement would make sense. This has potential for a world class tourist destination that is not just the West Linn Waterfront project but the Willamette River project. This is already a Heritage District and can bring a lot of attention, look for 2018 to be a big year. Other entities anxious to become involved but we need to keep this as much as possible in house, getting it done better and faster. Discussion around METRO, what their interest is and how much control would they try to take. Hopefully this a consistent EDC agenda item, take leadership in this project. EDC needs to understand the entire <u>Citie'sCities'</u> vision not just this committee. John Morgan explained he is the lead for staff and should be the EDCs contact rather than Bev Burke suggestions other committees need to send reports to the EDC.

Next open house will we be using social media to inform citizens of the events and early contacts? Rachel Vidin invited John Morgan to come speak at the Transportation Advisory Board meeting to discuss the transportation options that will be focused on at the next Waterfront Open House.

Old City Hall/Tourism Update:

Jody Carson told the WNA that the tourism board has leased a suite off Blankenship. Where does this leave the old police station, maybe this is something the EDC would like to work on. This is on the City's historical roster not the designated nationally. Has anyone started applying for grants for the building or anything on the waterfront? Will go after grants when there is a plan.

Election of Officers:

Russell Williams moved with a second from Bev Burke to elect Gail Holmes as Chair. Gail accepted, vote unanimous. Bev Burke moved to nominate Rachael Vidin as Vice Chair, Gail Holmes second. Rachael accepted; vote unanimous.

New Business

Chamber Report:

Russel Williams stated the Chamber ended the year with a Holiday Happy Hour, they also doubled their profit for the year. The Chamber has relaunched their website. New memberships and registration for events can now be done online. The next big event on January 30, 2017 is a preparing for disaster event; cohosting with Marylhurst University. You can sign up for e-blasts that goes out once a week. They are looking for a new location for the office.

2018 County Tourism Grants:

John Morgan reported that it is basically the same as before with \$20,000.00 allocated to West Linn, great criteria got to be something that increases overnight stays. Discussion of how many B&B's in West Linn but only one is legal, by registering with the County. What happened to the lodging tax that the EDC is looking for; Richard says on Council's list to look at not at the top. This is a revenue we should be looking at. Rachel says the Main Street group is looking at it and could give information this the EDC. Discussion on how to get the Airbnb's to comply. Can we work with AirBnBAirbnb so not to alienate the home owners? Inform them they need to have a city business license and register with the County. Put on City website, put in the weekly newsletter. Russel Williams moved with Bev Burke as a seconded to recommend to Council consider imposing a transit occupancy task; passed unanimously. Grant applications have to be by March 5th, so needs to be on the EDC March agenda. Need to announce that we have grants that need to be applied for. John Morgan to pass to Courtney Flynn to post to social media.

Economic Development Committee Retreat:

Gail Holmes discussed said we talked about strategic plan before and be putting toward their vision of what they want this committee to be. Gail believes that the retreat needs to be more structured. It would be fun to do personality test learning how to communicate, a team building concept. What does the committee want to do, evening might be best. Rachel Vidin thinks that these is a bonding experience and be light, not have an agenda. If we are talking strategic planning she is concerned they have the right idea about what the retreat is. Maybe agenda should be to have fun. Gail Holmes thinks we should discuss hope and dreams, why are you on the committee? John Morgan has authorization to pay for a reasonable food bill. Retreat should be off site, how about a room in a restaurant. Discussion around timing. Gail Holmes will call the 503 for a room and do a doodle poll for best time. Suggest three hour time frame.

Other items of interest

EDC Members

Shannen Knight:

There was a really interesting history lesson s from a WNA members who is English on the origin of a "public house". The member also discussed traffic issues that are similar in England and how they took to the water as they could not expand the roads, interesting to think about that; tourism, commutating.

Bev Burke:

Bev was contacted by a neighbor about an Arts Council in the City, the neighbor asked if Bev could bring to the EDC not just art around the City and also reach out to local artists for arts tours around the City. Richard Sakelik discussed that an Arts Commission (advisory board) is on the Council's retreat agenda especially with the waterfront project. Bev asked Richard to let council know that this was brought to the EDC; there is a study that art in a city encourages economic development. Richard believes this will get traction. We need a good social media campaign to get this moving.

Bev wondered why the city does not look at more condo development in the City. This would be a good source of revenue. As we only have some much industrial land that condos could bring a different socioeconomic base. Discussion around there are some lands that would work for this such as HWY 43 and would fit into that concept plan. Infrastructure is an issue and we need to work on transportation along with this. It is a low priority for Tri-Met to have a bus go up Salamo so it would be best for the City to establish our own shuttles and maybe partner with Oregon City or Mary's Woods as they talked with the City last year. Maybe we could do a year test to see if this would be a success.

Richard Sakelik:

Asked if everyone got an invitation to the January 29th Citizen Advisory Group Training.

Review of Agenda

Review and Selection of CPP Grants moved to beginning of agenda.

Review and Selection CPP Grant Requests to be recommended to Clackamas County Tourism: there is \$20,000.00 to award; discussion around the 4th of July celebration and that the City will now manage. Shannen Knight, makes a motion to not consider the 4th of July application; Kazi Ahmed seconds; motion passes unanimously.

Gail Holmes suggest going in the number order on the spreadsheet. Before starting discussion regarding Historic Main Street and not receiving the money from last year's award for the walking tour. This has been on hold waiting for the City component before the grant money will be allotted for the app, QR code, and Web site.

Ranking will be done on supplied spreadsheet for the applicants. Discussion about how the applicants should be scored, score as you see it. Based on application, how it is written and the criteria list, sometimes it is not clear from the application. Initial scores given and the average final score listed. Kazi Ahmed thinks the applicants should come in and make a presentation. Six months from now we should let citizens know in advance. Discussion of group; we need a better outreach. If people do not know we have these grants that is a shame; need earlier announcement and promotion. It does go in the newsletter, which some think no one reads, past participants and inquirers do get an email, and if you part of the County Tourism newsletters it is in there. People completing the grant forms need to do a better job completing the information required on the form, as compared to coming in and presenting. There is an agreement it I is easier to present in person when you can't always express on paper. Kazi Ahmed wants only to get a better understanding on the applicants. Not everyone agrees on presentations due to time and knowledge of technology. Paper applications is the most level playing field.

Linger Longer: Average score 53.8. Shannen Knight recused herself from voting

Good way to identify rooms available and the City could apply a fee, and fee would be decided. Build a page on the Main Street website specific to lodging. There are 30 Air B&B's in West Linn and only two that are legally registered with the county. Outreach to Air B&B's to get legal letting them know they would then be eligible to be included on the website. We would also draw revenue to the City with a room tax and business licenses. The City should be regulating this and they are not, this is one item on Councils list to generate income. This is a free marketing plan for B&B's using Facebook ads, Main Street will a hire company to handle the ads. Bev Burke sees this as a wishful thinking and blue sky grant. Initial scores where changed by some members.

Living History Tour: Average score 44.9.

If you look at criteria some items on application are not allowed. Maybe the horse drawn carriage and printing. They will be a later discussion on how much money to give out. They are not asking for full funding, asking for \$5,000.00 when you at the program overview sheet it makes Gail nervous on things they are asking. Gail thinks it is a great event, wishes it was held for more days as it sells out quickly. Shannen agrees it has no potential to grow so has to ask for grant every single year; not self-sustaining. Kazi Ahmed believes, this is a small, limited, event. Bev thinks they could push harder to supply subjective numbers for the application which would give themselves additional information on hew to improve the event. This event needs to be expanded which is difficult as people are required to move cars in a six block radius and modern conveniences from their homes. This is an ongoing request and how long should grants be given and is there not a limitation? Should the group be asking for less money every year? This is a problem with people writing grants, this is all volunteers. Group asking for \$2,000.00 for scriptwriting, which cannot be done; possibly fund \$3,750.00. General consensus; need to become self-sustaining.

97068 App, Average score 42.3. Gail Holmes recused herself from voting.

App and website, it takes 6 to 9 months to app finished through phones. It is the security components that take the time. Discussion around making website mobile convertible. John Morgan noted that the County Staff has concerns with this application as it appears to be a private venture looking for venture capital and not a nonprofit. Gail believes the County is contradicting themselves as the program overview say it can be awarded to a private, public, or non-profit organization. Bev thinks another applicant with lot of blue sky with no real objectives on how they are going to do it. How is this going to attract additional people to the area? Once people are here there is good information, but this app is competing with Yelp, Google Maps, Trip Advisor, etc. The County has concerns on how would people even know this existed? They would have to advertise via social media, place signs at baseball fields and such to download this free app. John Morgan says Sunriver has such an app and it is very active although Sunriver is different as an established tourist destination. Jennifer believes that of all applications this most of the criteria and one of the better ideas. Russell looking form a consumer perspective and believes it has no value as an example he would use Trip Advisor and if he downloaded the app he would delete the day after he left town. Shannen think this is a great app for citizens of West Linn not so much for tourism.

Willamette Falls Heritage Collation Booth and Material, Average Score 55.9

1st Annual Traditional Salmon Bake and Music. Bev disappointed that the application calls for handing out paper which is not sustainable, will go in the ground or garbage, and believes app would be better. Scores high for having multiple partners but this does not seem modern and she does not see how they could become operational. Shannen has concerns on how the event would directly benefit West Linn, as the salmon bake would be at the end of the Oregon Trail. Russel shares Shannon concerns, sure brings people that have never been to it, but not benefitting West Linn; no hotel, no shopping district here. Kazi likes the fact that is does not involve just us, it encompasses a larger area. This could be beneficial if it draws some of its energy to us.

Octoberfest, Average Score 28.7

Gail is disappointed there is no advertising, we need to get the tourism groups to advertise to draw people into West Linn. It is a reoccurring event that they should have figured out by now how to market. This is not a money maker, seems more like a local event. Bev would like more objective numbers to quantify the event. Could be fun but needs work.

Haunted Trail, Average score 64.0

Shannen has issues with a grant as this is a charged event; they charge money and seem to be making money so why do they need money? Russel sees outside people coming to the event but no sustaining them; they come to the nighttime event and then leave. It is a fun successful event, a lot of the communities kids come, does draw some outside people but they could sustain themselves. This is a City sponsored event, where does all the money go? There is no reason for anyone to stay and spend additional dollars in West Linn. Tourism money should not be given away; we can give a lesser amount then what they are asking for.

Farm Loop, Average Score 62.6

Reaching out to several communities, shared tourism. Bev think their website has improved from last year; but everyone little town is listed except West Linn on the map. There are a couple participants in West Linn, we asked them last year to include our town and that has not happened. If they want some money we have to be included. Russell sees they are asking the same amount form several cities where we may not benefit as much as the other cities with more farms. Where will the people go, to the area with more farms like Wilsonville? Even though farms may technically be out of County, most people think of this as West Linn and they carry at 97068 zip code. We must be included on the map if money is awarded and signage should be available and obvious to follow.

Lighting of Maddox Woods, Average Score 5.0

There is no information on the application, there is a cover letter from the Friends of Maddox Woods discussing the history that took place in Maddox Woods. No change of numbers as application is incomplete.

People are asking for \$38,480.00 is what people are asking for if we remove Maddox Woods and the 4th of July; we only have \$20,000.00 to award.

Jennifer Harmon makes a motion to award the tourism grants as reflected on the spreadsheet to conditions listed. Bev Burke second. Approved unanimously.

If we give feedback on why these decisions were made and why no money was given to some applicants this will be good feedback for the applicants.

Shannen Knight made a motion to request the County to create a way to give the applicants more feedback on why decisions are made. Rachel Vidin seconded. Passes unanimously.

Forward to next agenda to see if the County agrees to this.

Old Business

Mixed Use Task Force:

Shannen Knight gave a report on the Mixed Use Task Force. The only that that has happened in the last meeting was discussing was requesting from the City was adding to the Mixed use and Commercial Zone the ability to have small scale manufacturing added to the code. Wording of, a certain percentage of the floor could be for manufacturing the rest has to be for retail sold on site, not wholesaling. The task force will meet again next week. This will go to Council who will then revert it back to the Planning Commission to follow the proper procedure.

Waterfront Project/WLP Mill Update:

John Morgan talked about open house to be held at the Library on April 3, 5:00pm to 7:00pm, focusing on transportation and street projects. Boiled down to three alternatives that the public accepts and are viable. Open house at Library on April 5, 5:00 to 7:00 pm on general Land Use patterns. Based on what comes out of the open houses, we will start forging an actual draft. The legal issues are settled with the ownership of the mill, the major investors own the assets; now we will be able to move and do things. Conversations are being held with the land owners, especially PGE, and it will be an interesting year.

West Linn Chamber Activities:

Russel Williams discussed there is a Linked In network event to be held at the Willamette Christian Church, with a guest speaker. They will be closing the physical location of the Chamber which will now be virtual.

Other items of interest

EDC Members

Shannen Knight gave comment on the people interested in going into the gas station in Willamette and being displeased with the \$1,000.00 fee to paint the building; required to go to the Historic Review Board as it is in the Historic District. Is it possible to have a palette of acceptable paints colors requiring no public review and fees as an option? If applicant wants to paint the building another color they would have to go to the board.

Bev Burke makes a motion for the HRB to support the business community in West Linn by adopting an acceptable color palette of 5 colors to paint buildings as in the sign code with no public review and no fees as an option to the permit process which is still in place for other colors. Kazi Ahmed seconded. Passes 5 to 2.

It was discussed because the station is the last property in the Historic district the City had recommended that they petition out of the Historic District.

Gail Holmes went to a pre-app meeting for the Shari's building which will come down and discussed separating it for a dental office and a fast food restaurant. Gail Holmes suggested to them they would be a hero to buy the property behind them and put an additional road into the property as 8th court is a mess, all in agreement. Discussion around the Planning Departments role, Gail Holmes remind them this is only in the pre-app stage, Shannen Knight believes that Planning will push through residential

development to collect hundreds of thousands of dollars in SDC's, and okay we don't' care about the code and they will interpret the code loosely, and but if it is a business they are reading letter to the law. Members of the EDC wondering why are we here if Planning keeping shutting business down, John Morgan asks when the EDC committee is planning on having a strategy meeting. Richard Sakelik said as far as 10th Street goes that is part of the GO Bond and transportation improvements, they have not really defined what that is yet. Richard then asks the group what economic development piece would impact or be enjoyed by the GO Bond. Council will be attending NA meetings to explain where we are at with project.
