For reference, excerpt from City Council's 3/7/22 Work Session Agenda Report:

"Grants to businesses: \$225,000. Direct grant awards to local businesses in 2022, as follows:

- \$75,000 in technical assistance grants to businesses citywide to assist with needs such as business plan development, web site development, marketing plans, and similar activities.
- \$75,000 in unrestricted COVID mitigation and recovery grants to local businesses citywide, similar to previous funding rounds from the City.
- \$75,000 for façade improvement matching grants for brick and mortar businesses citywide."
