1. Call Meeting to Order

Chair Dean called the meeting to order at 6:00pm.

2. Public Comment

Victoria Meinig introduced herself and explained her interest in learning about the EDC and contributing to discussions.

3. EDC 2025/26 Workplan

The committee discussed strategies for attracting businesses to Westland, clarified its purpose, and emphasized the need for a clear work plan while gathering member input and collaboration opportunities.

Workplan

- Chris Myers provided context: Council requested proposed work plans for advisory groups.
- Timeline discussed: Work plan to cover activities through December, with Council review on Monday.
- Strategy: Collect feedback from committee members prior to next meeting to have a robust discussion.

EDC Vision Statement Review

- The group agreed to revisit the vision/purpose statement.
- Chris Myers will circulate the current statement for members to provide written feedback before the next meeting.
- Discussion focused on aligning the vision with members' goals and capabilities without changing the overall role of the EDC.

Partnership with Chamber of Commerce

- Victoria Meinig discussed collaboration opportunities, including:
 - Researching existing programs to support current businesses.
 - o Identifying opportunities to attract new businesses to Westland.
- Jared Dean suggested collecting committee members' availability, skills, and interests to guide involvement.
- Victoria Meinig and Steve to work on a recruitment work plan and present it to the committee for further discussion.

Committee Member "Why" Statements

Members shared motivations for joining the EDC:

- Jared Dean: Increase attractiveness of Westland for businesses, leveraging personal energy and ideas.
- Chris Myers: Support local businesses, address lack of commercial tax base, contribute to waterfront and Highway 43 projects.
- Shannen: Support small businesses, improve business retention and attract tourism.
- Russell Williams: Influence supply of business space, expand local tax base, support projects like waterfront development.

Survey

Chris Myers will draft a survey based on the discussion and send it to Jared Dean for review and edits.

- Agreement to develop a survey for committee members to collect:
 - o Time commitment and availability
 - Skills and relevant experience
 - o Areas of interest within the EDC mission
- Discussion of including a SWOT analysis in the work plan presented to Council.
- Consensus to vote on adding the SWOT analysis component to the work plan for Council consideration on Monday.
- Emphasis on completing preliminary survey work before the next meeting to inform discussion and finalize the work plan.
- The group will discuss the survey results and work plan ideas at the next meeting.
