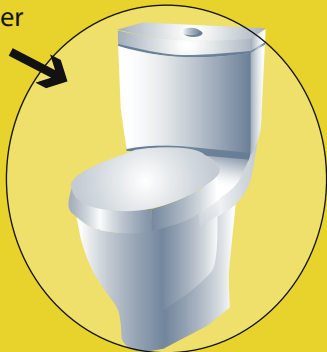

1 TOILET REBATE

Older toilets use 3 1/2, 5, or even 7 gallons with every flush. **High Efficiency Toilets (HETs)** use only 1.28 or less gallons per flush.



DID YOU KNOW?

Replacing a 3.5 gpf toilet with a 1.28 gpf WaterSense toilet could save as much as 4,000* gallons per person per year.

*Based on the national estimate of 5 flushes per person per day.

1. The Clackamas River Water Providers are offering up to a \$100 rebate when you replace a toilet that uses 1.6 gallons per flush (gpf) or more with a new WaterSense certified HET toilet.
2. The HET toilet you purchase must be WaterSense certified. For a complete list of eligible toilets, visit: www.epa.gov/watersense/pp/find_het.htm.



Apply for up to a \$100 rebate when you replace your current water-wasting toilet with a new HET High Efficiency Toilet.

LIMIT: 1 toilet per household. Please allow 4-6 weeks for processing.

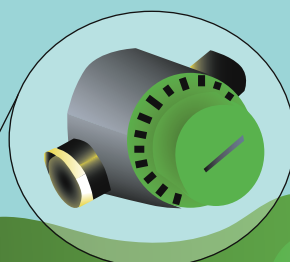
Apply for up to a maximum combination outdoor rebate of \$50 when you purchase a rain sensor and/or manual hose bib timer(s).

LIMIT: 1 outdoor rebate each per household. Please allow 4-6 weeks for processing.

3 MANUAL HOSE BIB TIMER:

Never again forget to turn off water! Hose bib timers turn off sprinklers at pre-set times.

Rebate: Actual cost – up to \$25 maximum.



OUTDOOR REBATES (2 CHOICES)

The Clackamas River Water Providers are offering (2 choices) in outdoor rebates. Customers can take advantage of each rebate one time per account.

2 RAIN SENSOR/SWITCH:

Temporarily shuts off your automatic irrigation system when it rains.

Rebate: Actual cost – up to \$25 maximum.

DID YOU KNOW?

Over-watering is the #1 cause of wasted water in the summer and the leading cause of plant disease and insect problems.



REBATE ELIGIBILITY REQUIREMENTS

Applicant must be a Clackamas River Water Providers customer.

- You must be a Clackamas River Water Providers (CRWP) single-family residential customer or a small business (50 employees or less) which owns its own site. You must receive water from one of the following water providers; City of Estacada, City of Gladstone, Oak Lodge Water District, South Fork Water Board (Oregon City and West Linn), Sunrise Water Authority (Happy Valley and Damascus), and your account must be active and in good standing.
- The HET toilet you purchase must be WaterSense certified. For a complete list of eligible toilets, visit: www.epa.gov/watersense/pp/find_het.htm.
- For HET toilet rebates, a copy of the dated sales receipt (or invoice) that specifies the toilet brand/model. The toilet brand/ model shown on the receipt must match the eligible model list exactly. Tank and bowl numbers cannot be mixed and matched from different models – they have been tested in specific combinations for performance and efficiency.
- You must recycle your old toilet at Environmentally Conscious Recycling (ECR). Cost is \$7.50 per toilet. A scale ticket will be required as verification of recycling – be sure to request a ticket from ECR, located at 12409 NE San Rafael, Portland, OR 97230, (503) 253-0867 or ecr@ecrrecycling.com.
- For all other rebates, a copy or original of the dated sales receipt (or invoice) that specifies the brand/model must be included with the rebate form. The brand/model shown on the receipt must match the item exactly.
- Rebate items must be installed at the property associated with your water account.
- One of each rebate per eligible account.
- A limited number of rebates are available each year.
- Rebates are available on a first-come, first-served basis. The program will end when funds are depleted.
- The total rebate per item will not exceed the receipt amount.
- The application must be received within 3 months of purchase.
- Apply for each rebate separately or at the same time.
- Rebates are for new products only. Pre-existing products are not eligible.
- Prior to approval, an on-site inspection may be required by CRWP.
