Call to Order Citizens' Budget Committee Meeting

Members of the Budget Committee Present:

City Manager Chris Jordan, Chief Financial Officer Richard Seals, Assistant City Manager Kirsten Wyatt, and City Recorder Kathy Mollusky.

Distribute 2014-2015 Proposed Budget to the Citizens' Budget Committee Members

City Manager Chris Jordan distributed his Proposed Budget, Capital Improvement Plan, and Supplemental Budget materials which include Issue and Option Papers, Community Grant information, and Third Quarter Financial Report. He stated Chief Financial Officer Richard Seals is available to meet with anyone to answer questions.

Presentation of City Manager's Budget Message

City Manager Chris Jordan's Proposed Budget Message stated that the Council goals are all funded. He discussed items that are not funded: Public Employees Retirement System (PERS), Taxes, and Insurance pressures. Ideas were implemented from the Community Values Forum and the Internal Budget Group. Overall fulltime employees are down 6%, from 139 employees in FY09 to 124. Following are some of the fund highlights:

- General Fund City Council City Attorney Services and legal fees are down City Manager Department - Communication Department/Communication Position was eliminated Economic Development - This is a new department, we are sharing an intern with the City of Sherwood Human Resources Director is moving to half time Finance - Arrangement with City of Milwaukie continues at half time; Payroll position was moved to Human Resources Information Technology - outsourced leadership to Polar Systems located in West Linn Municipal Court - Administrator reduced to half time Public Works - Civil Engineer laid off
 Police - Eliminated two positions, a Captain and an Officer
- Library Eliminated two management positions
- Parks Proposed a 5% fee increase; Director moved to half time
- Planning Two Planners were moved to half time
- Streets Proposed 5% fee increase
- Water Proposed 5% fee increase
- Environmental Services Proposed 5% fee increase

City Manager Chris Jordan Presentation

Mayor John Kovash asked how the next meeting is going to be conducted and how can they be most effective.

City Manager Jordan will walk through the budget fund by fund. When they arrive at a fund with an issues and options paper, they will focus on it. Then they will go through capital improvement plan. He suggested as the committee goes through the document, they write down any questions.

Vice Chair Bill Hill asked if they will be able to discuss water lines. He requested a map showing the area of community, time frame, cost, etc.

City Manager Chris Jordan stated they will be able to discuss water lines. They have the Master Plan that shows the cost. He will have Public Works Director Lance Calvert discuss the priorities and bring a map showing the plans for the next couple of years.

Mayor John Kovash stated one goal is to determine the problems with the water system and how to fund it.

Chief Financial Officer Richard Seals informed everyone that copies of the budget are available online.
