President Karie Oakes called the meeting to order at 7:09pm, noted a quorum was present and members introduced themselves.

Approve agenda moved by Christa Birk, second by Teri Cummings, unanimous.

Approve minutes of March 26, 2024 moved by Jim Koll, second by member, unanimous.

**Treasurer Report** Jim reported the balance \$8530.91, with monthly expense Zoom \$15.99.

**Pedestrian Plans in the 2016 WL Transportation System Plan pertaining to Marylhurst** Karie presented the *Pedestrian Plan Improvements Projects-Updated March 2024* map and projects list (attached). The update reflects completed projects and is under review by the Transportation Advisory Board (TAB). <u>What is the purpose of the review?</u>

Members discussed the following projects and noted some questions (underlined). P80 Marylhurst DR-install sidewalk on south side from Hillcrest DR east (lower) end to Hwy 43 (Willamette DR). The city has partnered with a development to complete the section from Midhill Cir to Hwy 43. Will it include a right turn lane as shown in the Hwy 43 Infrastructure Plan? Members noted topographical restrictions and asked if any engineering analysis had been done. P101 Hillcrest DR- install sidewalk on one side from Suncrest DR to Marylhurst DR. It was suggested that safe pedestrian walk could be implemented without sidewalks, i.e. get the debris and vegetation off the pavement and not obstructing the fog line. **P94 and P95 Suncrest DR**-install sidewalk on east side and west side respectively, from Valley View to Hillcrest DR. What are the criteria or code for sidewalks if a property is redeveloped? **P96 Suncrest DR**- install sidewalk on eastside at Ridgebrook DR along island county property. This infill piece would occur if property is annexed and redeveloped. P70 Carriage Way- install sidewalk on the northwest side along the undeveloped Marylhurst Heights Park property and along county properties to Rosemont DR. Park development would trigger sidewalk installation. Presumably, the priority level was medium because of these factors. It was noted there was a sidewalk along the other side of the street.

All of these projects are designated high priority except for P70. To be funded, projects would have to be added to the Capital Improvement Plan and approved in conjunction with the biannual budget.

**Neighborhood Plan Goal 4 Transportation**- Karie presented pages 13-14 (attached) and members reviewed **Policy 4 Develop and maintain safe and convenient places for pedestrians including sidewalks and paths.** Encourage residents to maintain sidewalks adjacent to their homes, work with city to prioritize needed sidewalks/paths, link sidewalks to adjacent neighborhoods and community, and transit stops. It was noted that MNA previously worked with the city to raise the priority level of Marylhurst DR. and more

recently, to encourage residents to maintain right of ways adjacent to their property. Likewise, this policy will guide our work to identify where we want and do not want sidewalks. Homework is to walk neighborhood and think about where we would like sidewalks to be added in our neighborhood. Add this to open discussion for next month.

**Pedestrian Plan within the City Transportation System Plan** Karie pointed out pages related to Marylhurst. Page 21- Marylhurst DR has significant grade and topography which may limit ability to construct a sidewalk on one or both sides of the street. Page 26-possible connection from Hillcrest CT to Marylhurst DR however slope is steep and no ROW. Page 25- Trails Master Plan Map shows secondary on-street trail and off-street trail through park. We may want to revisit it to inform our work regarding sidewalks. Reviewed strategies to meet pedestrian needs: 1) Continuous pedestrian facilities along arterial and collector streets. 2) Provide access to essential destinations. 3) Provide access to Metro and Clackamas Co routes. 4) Prioritize improvements on streets that give the greatest benefit to the system. Page 27-This is the Pedestrian Plan Projects map that was updated for TAB. We can recommend changes. Changes go to the Planning Commission for review and recommend and to City Council for approval.


**Social** Marylhurst Heights Park Shelter A (next to playground) is reserved September 7<sup>th</sup>. Time, activities, food would be suggested by a planning committee. **We are looking for volunteers.** It was suggested to do a postcard to "save the date." We could replicate last year's event. It took a lot of planning. Members discussed past socials: potluck, barbecue, ice cream sundaes, craft fair, face painting, sidewalk chalk, clay play and new activity ideas: music, harvest party, contest (Bolton NA does pumpkin carving contest), pot party in Spring where plants are shared. We could hire professionals for music, sidewalk art, other activities. The magnitude of the event will depend on the level of volunteerism.


**Potential Spring Clean-up Day** Robinwood Neighborhood Association asked neighborhood associations if they would be interested in street and park clean-up on a weekend day before or after Memorial Day-details TBD. It's uncertain if city would provide receptacles but city would provide gloves and safety vests. RNA would organize and publicize with the city. Karie noted this event would further our work for neighbors to cleanup ROW. A member noted that the city had picked up vegetation at the park and on Marylhurst Dr. for previous MNA clean-ups. Move to participate if city picks up refuse, no second. There was consensus that more details were needed and we probably didn't have the volunteers and enough time to help plan it.


**Items of interest** A member pointed out that street sweeping had not occurred, invasive Tansy Ragwort in the ROW needs to be removed, and mosquitos and Box Elder bugs controlled. They noted sweeping beyond the fog line makes it safer for pedestrians.


