SB 1573 and Potential issues, Law Suits, City Charter impacts – Status

• Home rule allows the city to decide its own destiny...13 cities have stated that this SB impacts their charters...Home Rule allows cities to determine how they will grow and what their growth looks like. Destiny function and run, there was an understood rule, by the state passing this law, largely put together by builders, developers, property owners. We are a member of LOC and they filed a law suit, so we are tracking the issue through their action. The matter is in a different district court, so we couldn't join the suit, but we are tracking it. Litigation is in play and we will need to address the matter again when the courts make a decision.

City of West Linn Community Development Director

• The City Manager hired a new Development Director – John Williams. He was previously with Metro and the City of Canby

Community Safety and Public Concerns

• Mayor Axelrod reported that the City has reaffirmed in the City its commitment to safety. The City is seeking input and feedback, regarding becoming a sanctuary city and certain measures that are taken regarding people's immigration status and what the police can or can't do and without understanding or being fully versed in all police policy we (the Council) didn't have enough information to address all the issues, but we wanted to get something out, so that's why we put together the current proclamation. The Council is open to evaluating comments from citizens on how we may supplement the proclamation and how we can incorporate measures that work for West Linn. The essential message is that we are not going to tolerate hatred, discrimination, of any king anywhere, bigotry, bullying, sex, no matter what the orientation is. So I am really proud of that...

School District Boundary Changes

• The Mayor discussed meetings with the local school district and a discussion unfolded about the history of how the West Linn / Wilsonville School District was formed.

Hwy 43 Multi Modal Transportation Safety Project

- Chair Schwarz moved on to the next agenda item regarding the Hwy 43 Transportation Safety Project. Chair Schwarz mentioned being in a good place regarding the allocation of funds and asking the NAP group to support the measure so that he can give testimony on behalf of the NAP group.

We want to encourage members of the NAP group and others to come to the meeting, voice opinion, participate and give everyone a chance to understand what is going on... January 24, 2017 meeting in the Library at the current Sunset School.

- Savanna Oaks Ed Schwarz, a party attended our last meeting and gave a presentation about recycling. I can forward the name of the Master Recycler who gave the presentation for those NA interested in adding it to their agendas.
- Skyline No Report
- Mayor Axelrod and Commissioner Jim left the meeting due to concerns over a conflict with information that Kazi is going to discuss.
- Robinwood Kazi Future development and softening the approach its all about the money – he is not backing down...wants to go around the City Council and Planning Commission – there is a process for an expedited hearing and he will go that route...
 There is an effort underway to buy land for park use. In addition on Hwy 43, Mary

Woods has its own development in process and that will cause traffic concerns...and that along with townhouses currently going in development along Hwy 43 will cause more congestion along a corridor that is already overloaded.

- Bolton Steve Election were held, I will be President and Alan will be Vice President
- Sunset Elections Patrick Noe, Jerrod Gaylon, and Leslie Bowlin elected...master NA program was discussed - some kind of APP to prepare for emergencies, a presentation to come in next month... Nextdoor etc, earthquake preparedness, LUBA land use appeal for the Sunset School site.
- Chair Schwarz reminded those that have held elections to let the city community coordinator know so that email and other information can be exchanged.
- Barrington Heights elections and fair amount of vandalism on holiday decorations the HOA spent \$12K on decorations and damage has occurred...some homes have also had damage...
- Parker Crest NA Relyea mentioned there appears to be an upswing of information being posted on Nextdoor Neighborhood about potential John Does and unwanted or questionable behavior, people posing as Direct TV representatives, looking in backyards, collecting notes about who is home and who is not if we don't take an active stance and report matters to the police they can't respond The NAP's should encourage citizens to report these issues to the police. Working with the City Park and Recreation Department to sponsor a Music in the Park event the NA will likely purchase a banner to increase exposure and show support for how NA's work to improve life for the citizens of West Linn. There are two properties each having approximately 3.5 acres coming before the City Council in January for annexation.
- Marylhurst NA didn't reach a quorum at our last meeting. Teri Cummings was elected as
 a City Councilor and she was the NA secretary we will have elections to bring someone
 else in to that position some items about a boat and a bench, whether those items are
 on personal property or city property...the city asked about a fence, some issues with
 dogs...We had some signs purchased for notification about NA meetings...the signs were
 purchased on the internet, we will be getting new signs and we will use a part of them.

 January for a retreat to set our 2017 goals we would like your feedback prior to our
 retreat We are retreating on 20 and 21 January Get your goals and accomplishments
 in...common voices, things that we can do together...that the council can facilitate...
