Christine moved to approve the agenda with the changes, Vince seconded 5-0-1 unanimous.

Devani moved to approve the motion to accept the minutes, Vince 2nd 5-0-1 unanimous.

No CCI news

City Council liaison is now Carol Bryck. City Council public comment changes vote at next City Council meeting.

NA Handbook – change on page 3 eliminate # of residents in each NA, need clarification on if NA is an Advisory Group,

CJ feels that this would be helpful for new people. Motion to accept NA Handbook with said changes (including that # of residents in each NA should be made with 2020 census): Kathie made the motion with Kevin seconding, unanimous. 6-0. City Staff to get back to us by Nov. NAP meeting.

Training program workshops – to be held by NAP in 3 separate meetings lasting 1 ½ hours for all officers. The first meeting could be on land use, second on public meeting law/Roberts Rules of Order, the third training meeting is for people interested in, as well as roles for running meetings. The city attorney/in-house attorney should attend this meeting. More discussion on training during our next meeting.

Dog issue- Christine stated that she was in contact with code enforcement officer (limited staff) often can't get to people about loose dogs. The problem is across the entire city, it is happening in parks, school, and neighborhoods. West Linn does not have an animal control officer. Code enforcement is

under the Police Dept. CEOs are part time. Suggestions to help educate the public = OWL remind about leash laws, use social media, put up fliers on kiosks in parks, fine on the first infraction (at this time people are being warned). Implement the fines starting 1/2024. CJ will put this request together. Kevin suggested having Councilor Bryck bring this topic up for discussion.

Bylaws – Quorums, Land Use with different quorum, 2-year positions (2 positions elected per year with the other positions elected the following year) i.e., 1). President and Secretary on year 1 2). VP and Treasurer the following year.

How to make board members successful:

Virtual – storage and in person. Beau will speak with Terry (City IT) about storage.

The City needs a city-wide response on adjacent property right of way/upkeep. The city should use social media, OWL. Clarify the expectations of what residents are expected to do.
