Carol Bryck said she attended a meeting on 7/15 for the Down to Earth Forest School. It was a full house. They would need a conditional use permit. The league of Oregon Cities asks city councilors to send in their issues.

New state rules about min. parking with development. The Planning Commission will have 2 more sessions on this, then a public hearing. Middle Housing has no parking mandates.

Trimet starts new route next month to include more of West Linn.

City Attorney contract – new city attorney starts Sept. 9th

Nov. 5th ballot – increase stipends for councilors and mayor.

Boat trailer parking – 24 hrs. Trial period for 1 year. Only on 28ft. wide streets, 5 ft. width and 8 ft. length of boat.

Highway 43 and Waterfront Project – New survey with more pointed questions. Open next week for a month. Zoning changes to be discussed at the end of the year. Please go to the website. Robert Jester made the comment that the culture of the Planning Dept. is that they know better than public as to the needs of the city. NAs are a hinderance/deterrent to them. This is a bureau issue.

Robinwood – Aug. 24 At Robinwood Station 12:00 – 4:00 picnic brauts, salad. The sidewalk project is incredibly noisy.

Marylhurst – discussing pedestrian/bike safety. TAB working on sidewalk priorities. TSP hired consultants for costs to update the TSP. Eric to do a study on which side of the street a sidewalk should go on. A pedestrian path would be sufficient for neighborhood members. Sept. 7th Ice cream Social 2-4pm at Marylhurst Park.

Hidden Springs – been trying for years to get flashing beacons at Pimlico and Santa Anita/Salamo Rd.

SONA – Vision 43 presentation, ribbon cutting for Grandfather Cover (NA provided 50% donation and other 50% was private donations). Sept. 14 1-3 pm ice cream social at Douglas Park.

Barrington Heights- Megan BigJohn was a great hire. Plan to prioritize safety issues, prioritize city plans for development.

Barrington Heights pays to maintain a fire break on several pieces of city owned property. Resolve construction damage to related sprinkler issues.
