WEST LINN OLD TIME FAIR COURT RESPONSIBILITIES

Those selected for the Fair Court will represent West Linn at the Old Time Fair, July 20–22, 2018, in addition to other events throughout the year (see attached list).

Duties of the court include: represent the City of West Linn and the Old Time Fair at City sponsored special events and through attendance at selected neighboring community events, fair activities and meetings, participate in fundraising efforts for fair court related expenses. Fair Court members are also required to plan, execute and present an independent community service project.

The following will be provided for each Court Member:

- Formal attire for required appearances
- Casual apparel *tbd*
- Accessories including a crown and sash

The parents may be responsible to provide or assist with the following:

- Pants/shorts or shoes for casual wear
- Meals and spending money
- Transportation to meeting locations and supervision when indicated

Each court member is required to participate in a group fundraiser(s) and contact sponsors for donations.

An informative **Open House** will be held at West Linn Adult Community Center, 1180 Rosemont RD on **Wednesday**, **January 17**th **from 6-7 pm** to answer questions prospective princesses and their parents may have regarding the selection process and program commitment.

Applications are **due Friday, January 26th, 2018 by 4:30 pm** at City Hall, 22500 Salamo Road, 1st floor, Parks and Recreation Department. *Late applications will not be considered.*

The **selection** interviews and speeches are scheduled at the McLean House 5350 River Street on **Thursday, February 15th, 2018** beginning at **6 pm.** A panel of judges will meet with each candidate individually. Candidates will give a 3-5 minute prepared speech to introduce themselves and explain why they would make a good representative for the Old Time Fair and the City of West Linn. Four court members will be selected and announced at the end of the evening.

REQUIRED COMMITMENT

Parents should note that the commitment required for the West Linn Old Time Fair Court is extensive, not just for the royalty, but for the parents as well.
