- d. Ken Worcester Dredging the entrances to the Island & Slough in proposed budget (nothing below boat ramp) and the plan is to talk to Bob Martin, Rep for association. Dredging hard to accomplish due to permitting and the cost a decade ago was \$50,000 for permits.
