- 4. Community Comments:
  - a. Tom Meier addressed concerns about parking at Tanner Creek Park, asked why the Playtime scheduler was removed and what the updated dollar amount of the covered pickleball shelter project is.
- 5. Items of Interest from the Board:
  - a. Vicky would like board to get back on track with plans and strategies to move forward with GO Bond projects, especially Willamette Park and water access.
  - b. Stacy asked about the update on White Oak Savanna. Ken talked about the November 2019 meeting when council asked to have the playground downsized. The direction changed and Learning Landscape was going to come to a PRAB meeting in March to talk about different options to present at a community engagement event.
  - c. WOS-Mary received support from WNA and WOS for the natural playground elements. Mary asked how much money was left for the project, Sarah wants the entire community involved not just specific groups, Stacey suggest following the process from what was discussed in last meeting, Vicky doesn't want any more money spent and no more staff time on this project, John suggest putting the plan on hold.

  - e. Vicky motioned for staff to provide Metro info at next meeting, John second, motion carried.
