WORK SESSION - HIGHWAY 43 PLAN, PLN-15-03

Mr. Wyss outlined the four components needed to work this plan through the legislative process: 1) adopt the West Linn OR 43 2016 Conceptual Design Plan as attachment A of the West Linn Transportation System Plan Update, 2) make some changes (primarily cost tables) to the Transportation System Plan that was just adopted by City Council 3) make Comprehensive Plan Changes that were recommended as part of the Transportation System Plan Update, and 4) make Community Development Code changes that were recommended as part of the Transportation System Plan Update. Items 3 and 4 were tabled with the plan to bring them forward with the Highway 43 Plan Update.

Mr. Calvert and Ms. Kingsley provided the purpose and objectives of the West Linn OR 43 2016 Conceptual Design Plan update and answered commissioner's questions.
