PUBLIC HEARING - WEST LINN OR 43, 2016 CONCEPTUAL DESIGN PLAN, PLN-15-03

Chair Babbitt explained the Planning Commission's role in the legislative process is to make a recommendation to City Council, who will hold their own public hearing at a later date. He then provided an outline of how the meeting will proceed: after the preliminary legal matters, staff will make a presentation, the commission will have an opportunity to ask questions of staff, followed by public testimony. After the commission has a final chance to ask questions, the hearing will be closed and the commission will discuss the proposal and make a recommendation.

Ms. Thornton provided the preliminary legal matters.

The hearing commenced with a staff report presented by Darren Wyss, Associate Planner. The proposals under consideration are 1) to adopt the West Linn OR 43, 2016 Conceptual Design Plan as Attachment A to the Transportation System Plan, 2) to adopt amendments to the Transportation System Plan Cost Tables, 3) to adopt amendments to the Comprehensive Plan, and 4) adopt amendments to the Community Development Code. The Planning Commission has three choices: Recommend Adoption, Recommend Adoption with Changes or Recommend Not Adopting.

Kelly Boubel Shriver spoke.

Chair Babbitt closed the hearing and the commissioners entered into deliberations.

Commissioner Jim Farrell **moved** to approve the Highway 43 Plan with the recommendation that Council direct staff to propose additional options for Arbor Creek culvert crossing, the Hidden Springs intersection with Old River Road and the problems at Bolton School before the final plan.

The motion failed for a second.

Commissioner Charles Mathews **moved** to accept PLN-15-03 with the condition that the Old River Road and Highway 43 intersection be consistent with the prior 2008 plan. The motion failed for a second.

Commissioner Joel Metlen **moved** to recommend Council adopt the conceptual plan, PLN-15-03 with the condition that the city consider additional options for problematic areas in the plan before final design and engineering.

Commissioner Chris Myers seconded the motion.

The motion and second were withdrawn.

Commissioner Chris Myers **moved** to approve PLN-15-03 as drafted.

Commissioner Joel Metlen **seconded** the motion.
