Presentation by NW Vernacular

Ms. Pratt presented the methodology for the different routes, colors, symbology, and asked for feedback. Some of the feedback received was to revise some of the stops on the tour, making symbols larger, rotating the map, and making the map image larger on the page. The final map will be presented at the next meeting.

The Willamette United Methodist Church (WUMC) is working on a grant application with the intention of taking any awarded funds and beginning the restoration on the historic church structure. Debra Neel and Kathy Boyes both represent WUMC and shared their phased project with the HRB. As part of their grant application, they would like to include a letter of support from the Historic Review Board. Ms. Arnold asked Neel and Boyes to write the letter and email it to her. She would distribute it out to the HRB in an email, and send them a revised/ signed document.
