# BUSINESS MEETING CALL TO ORDER

Chair Lewis called the meeting to order at 7:06 p.m. in the Bolton Conference Room of City Hall, 22500 Salamo Road, West Linn, Oregon.

#### Approval of the January 23, 2018 Meeting Notes

Chair Lewis moved to approve the January 23, 2018 meeting notes as presented. The motion was seconded by Board Member Neff and carried 3/0/1. Vice Chair Offer abstained from the vote due to absence of the January meeting and Board Member Schreiber had not yet arrived.

## Approval of the April 17, 2018 Meeting Notes

Chair Lewis requested a change on the meeting notes as presented as Board Member Schreiber arrived. The requested change on the second page to strike who adjourned the meeting since Chair Lewis left the April meeting early. Board Member Schreiber moved to approve the corrected April 17, 2018 meeting notes. The motion was seconded by Board Member Inman and carried 3/0/2. Vice Chair Offer and Board Member Neff abstained from the vote due to absence of the April meeting.

No one from the public wished to speak during Public Comments.

## **Presentation by Jennifer Arnold (Planner)**

Ms. Arnold presented the latest draft of the Historic Walking Tour Map. Ms. Arnold noted some of the feedback received at the last (April) meeting and that there was a small amount of grant money still available to make final changes. The Board discussed the map and suggested some minor changes. These changes being: removal of location symbols 10, 16, and 24, then renumber these symbols. These markers needed to be removed due to errors on the map, age of the homes, or significant modification to the historic structure. Another requested change was to adjust an arrow at the corner of 6<sup>th</sup> Ave and 13<sup>th</sup> ST. The arrow should be imbedded within the route and not floating by itself.

# **CDC Chapter 25 Discussion for Suggested Revisions**

Ms. Arnold handed out a copy of CDC Chapter 25 to all members present, and asked them to all for any suggested changes in an open discussion. More discussion was centered on CDC Chapter 58 (Willamette Falls Drive Commercial Design District) than CDC Chapter 25. The Board directed Staff to provide language from neighboring Cities on definitions for 'scale and massing' for clarification in the CDC. The Board also discussed focusing on changing purpose statements to reflect the information contained in that section. Ms. Arnold asked if all members could bring comments to the next meeting to save time.
