Dear Darren,

This letter has been prepared on behalf of the West Linn-Wilsonville School District to request a formal pre-application conference with the City on November 4th to discuss the proposed relocation and new construction of Athey Creek Middle School on Dollar Street. The new middle school is part of the 2019 Capital Bond Program which was approved by West Linn-Wilsonville voters in November 2019. The school property is located at 945 Dollar Street. The property can be legally identified as tax lots 21E34DC00900 and 21E34C00600.

The new middle school facility would be built on the District's Dollar Street property, bringing it into West Linn so that students can walk and bike to a more neighborhood friendly location. The Dollar Street site would allow for a track, turf field and lights, parking and appropriate site circulation for both school and community use. The District understands that schools are a conditional use in the R-10 zone.

The following list of questions has been provided for staff's consideration:

- Please confirm the type of land use reviews which will be required for the proposed improvements.
- Please confirm the applicable approval criteria for the uses proposed.
- Please confirm whether any public improvements will be required to facilitate the development of the site.
- Please confirm the retaining wall and fence criteria within the required setbacks.
- The District is proposing a monument sign on dollar street and an electronic reader board monument sign on Brandon Place. Please confirm whether the proposed signage would meet the City's sign code.
