Thank you for notifying us of the upcoming pre-application conference for 1045 S Rosemont Road. Water Environment Services (WES) has the following comments:

Tri-City Service District (TCSD) is the wholesale sanitary sewer service provider for this area, however tax lot 21E23CD12600 is not currently within the TCSD boundaries. Therefore, prior to connecting to the public sanitary sewer system, this parcel will need to annex into TCSD. WES administers the annexation process on behalf of TCSD. The TCSD annexation can run concurrent with the City annexation, but it must be noted that these are two separate annexation applications and processes. The TCSD annexation packet can be found here: <a href="https://www.clackamas.us/wes/annexation.html">https://www.clackamas.us/wes/annexation.html</a> The estimated annexation fees are \$225 (payable to Clackamas County) and \$150 (payable to Metro).
