Subject: Amendments to the Community Development Code

There have been some regulatory improvement code amendments to the City of West Linn's Community Development Code, regarding minor text amendments for Chapters 2, 3, 8, 9, 10, 11, 12, 13, 14, 15, 16, 19, 21, 25, 28, 34, 37, 41, 46, 52, 55, 56, 57, 58, 59, 60, 66, 75, 85, 89, 98, 99, and 106. The amendments are proposed by Staff and involve language and re-formatting edits that correct errors, reduce ambiguity, and codify existing City practices; they are intended to provide greater clarity in the CDC for citizens and Staff. City Council enacted Ordinance No. 1604 on September 26, 2011 and became effective on October 26, 2011.
