#### Oregon Planning Program – Planning Background

#### Oregon's Planning Program History



- Senate Bill 100: Created Land Conservation and Development Commission
   (LCDC) and Department of Land Conservation and Development (DLCD)
- Directed LCDC to develop statewide planning goals
- Required all cities and counties to adopt comprehensive plans
- Gave LCDC the authority to approve or reject comprehensive plans
- Required state agencies to comply with comprehensive plans

### Oregon Planning Program – Planning Background Continued




The City's Comprehensive Plan was adopted on December 31, 1983. The Plan was developed in accordance with the Oregon

Statewide Planning
Goals and was
acknowledged by LCDC,
DLCD and Governor on
May 31, 1984.

This certified the city as compliant with the land use program.

A BIG deal!





#### Comprehensive Plan



- The City's acknowledged Comprehensive Plan (Plan) is a land use document that *guides* local policy makers.
- The Plan's land use policy aides in infrastructure development, conservation of natural resources, economic development, public services, and was (as acknowledged) found to have addressed all applicable state wide planning goals.
- The Plan is the basis for and implemented by, the community development code (or zoning regulations). Plan policies can sometimes be regulatory ("shall" statements) and are often organized consistently with statewide planning goals, but not always.

#### What Are the Support Documents?


The *plan is a set of findings, goals, policies and action measures* that address all applicable statewide planning goals.

The plan's support documents provide the *objective data and research* into current conditions, issues, and trends. This information can be found in the supporting documents:

- Public Facilities Master Plan
  - Transportation Systems Plan
  - Hwy 43 Corridor Plan
  - Sanitary Sewer System Master Plan
  - Water System Master Plan
  - Storm Drainage Master Plan
- Other plans exist (have not been identified as support documents)

- 2013 Parks, Recreation and

Open Space Plan
- 2013 Trails Plan





### Sanitary Sewer Master Plan

#### **BACKGROUND:**

- ◆ 1977 CRAG (Columbia Region Council of Governments) developed an area wide wastewater treatment management plan (208 Wastewater Treatment Plan.)
- 1980-85 Tri-City Sanitary District founded and funded with a bond issue.
- ◆ 1989 the City adopted a Sanitary Sewer Master Plan
- ◆ 1999 the City updated the Sanitary Sewer Master Plan
- The Current proposal before the Planning Commission is to make recommendation to City Council on the 2019 Sanitary Sewer Master Plan

#### Sanitary Sewer Master Plan

#### SUMMARY STATEMENTS

- The Sanitary Sewer Master Plan was part of the acknowledged Comprehensive plan and has been updated on two occasions.
- The Sanitary Sewer Master Plan is *listed as a support document* to the Comprehensive Plan. It is the technical inventory and assessment supporting the Goals, Policies and Action Measures adopted in Goal 11 of the Comprehensive Plan.
- The current review followed the DLCD Notice, legislative notice, and hearing process (notice and hearing) for the update of this support document.

## Planning Commission Recommendation for the Sanitary Sewer Master Plan



The issue before you tonight is the 2019 Sanitary Sewer Master Plan. The Planning Commission:

- voted unanimously (6 to 0) to recommend City Council to adopt the proposed Comprehensive Plan Text and Community Development Code Text amendments as identified in Ordinance 1695.
- Ordinance 1695 adopts the March 2019 City of West Linn Sanitary Sewer Master Plan

#### Sanitary Sewer Master Plan – Date Specific or Not?



#### What is the importance of the date?

- Provides a version specific reference for those items that are regulatory in
- Requires a Plan Amendment to update the Support Document.
- Allows the Planning Commission to revisit issues and comments on concerns that arose during development reviews.
- Is one of the few opportunities for the Planning Commission to provide feedback to the Council on policy making decisions.
