



All that portion of Lorinda Lane and Lorinda Court lying within the Plat of Le Chevalier and Northerly of a line described as follows:



Thence North 45°09'58" East 50.13 feet, to a 5/8" iron rod on the Easterly Right of Way line of Lorinda Lane.

ROADWAY TO VACATE



All that portion of Lorinda Lane and Lorinda Court lying within the Plat of Le Chevalier and Northerly of a line described as follows:



Thence North 45°09'58" East 50.13 feet, to a 5/8" iron rod on the Easterly Right of Way line of Lorinda Lane.


