Sara,

We aren't concerned about the code changes meeting CLG standards. Our concern about Planning Commission making HRB decisions is their lack of training in National and State preservation laws and standards. Much of what the HRB does is not supported in city code. The code gives them the authority to make decisions, then the HRB is trained to make decisions that will stand up to the standards.

In speaking with the PC at the end of the meeting they said there wasn't going to be any problems as long as decisions are supported in code. I doubt if they would be able to find most of the HRB decisions in the code without training in historic preservation. We can say HRB decisions are supported and show them where in the code, but without the background they won't see it. I've seen it play out this way over and over again through the years.

The PC in their decision to use #1 went back to where the changes were before we met with them. It completely discounted the two+ hours of discussion that aspects of the HRB decisions needed to be binding and discounted my testimony that whatever change they chose the HRB needed binding decisions. The frustration with this is at the same time they are discounting everything that was said to them they are assuring us that they always place high value to input from other advisory bodies and make sure they incorporate them into their decisions. I don't see where they've shown that they understand our concerns. The goal is to protect the historic resources that still remain in tact in the Commercial Zone and make sure that what is add complements it.
