In order to obtain Permit decals and/or hangers, all applicants must read the paragraphs below and sign.

I understand:

- It shall be unlawful for any person to:
- Provide false information in connection with an application for a permanent or temporary permit (hanger).
- Use or allowing the use of a permit in conjunction with a vehicle other than the vehicle for which the permit is issued.
- Use or allow the use of a temporary permit (hanger) in a manner inconsistent with the terms and limitations of the permit.
  - For persons only while visiting at your home.
  - NOT for use by friends/relative attending West Linn High School.
- Use a permit when the permit holder is no longer entitled to the permit.
- Fail to surrender a permit, when requested to do so, when the person is no longer entitled to the permit.

Violation of any of these understandings may result in immediate cancellation of the Permit Decal(s) and Hanger(s) in question. After cancellation, any vehicle(s) found parked in the Permit Area bearing said Permit Decal(s) may be cited, fined, and/or towed.
