

RESOLUTION NO. 2017 – 20

A RESOLUTION OF THE WEST LINN CITY COUNCIL EXTENDING THE RESIDENTIAL PARKING ZONE FOR THE CITY STREETS AROUND AND NEAR WEST LINN HIGH SCHOOL

WHEREAS, pursuant to West Linn Municipal Code (“WLMC”) Section 6.015(2)(i), the City Council has the authority to establish residential parking zones; and

WHEREAS, residents near West Linn High School have experienced problems with high school students parking vehicles on residential streets and congregating near the vehicles during school hours; and

WHEREAS, a residential parking zone was established near the high school to address these issues by Resolution 95-23; and

WHEREAS, the residential parking zone was extended by Resolutions 96-26A, 97-33, and 98-27; and

WHEREAS, residents on or near Easy Street and at the north end of West A Street have requested an extension of the zone; and

WHEREAS, WLMC 6.015(3)(a) requires that a resolution establishing a residential parking zone “clearly define the geographic limits of the area affected by the zone and the hours during which the parking by nonresidents will be prohibited;”

WHEREAS, the numerous resolutions and maps extending the district make it cumbersome to determine the boundaries of the residential parking zone as it currently exists; and

WHEREAS, one resolution adopting the residential parking zone with one map showing the residential parking zone, including all previous extensions of the zone, will be beneficial to residents.


NOW, THEREFORE, THE CITY OF WEST LINN RESOLVES AS FOLLOWS:

SECTION 1. Residential Permit Parking Zone Map. The geographic limits of the residential permit parking zone near West Linn High School are shown on a map, which is attached and incorporated as Exhibit A.

SECTION 2. Prohibited Parking. Parking on the streets within the residential parking zone without a permit will be prohibited on days when West Linn High School is in session from 8:00 a.m. to 3:00 p.m.


SECTION 3. Repeal. Resolutions 95-23, 96-26A, 97-33, and 98-27 are repealed. All other previous resolutions, if any, that established or extended the residential permit parking zone near West Linn High School that are not specifically listed in this Section are also repealed.

This resolution was PASSED and ADOPTED this 11th day of September 2017, and takes effect upon passage.

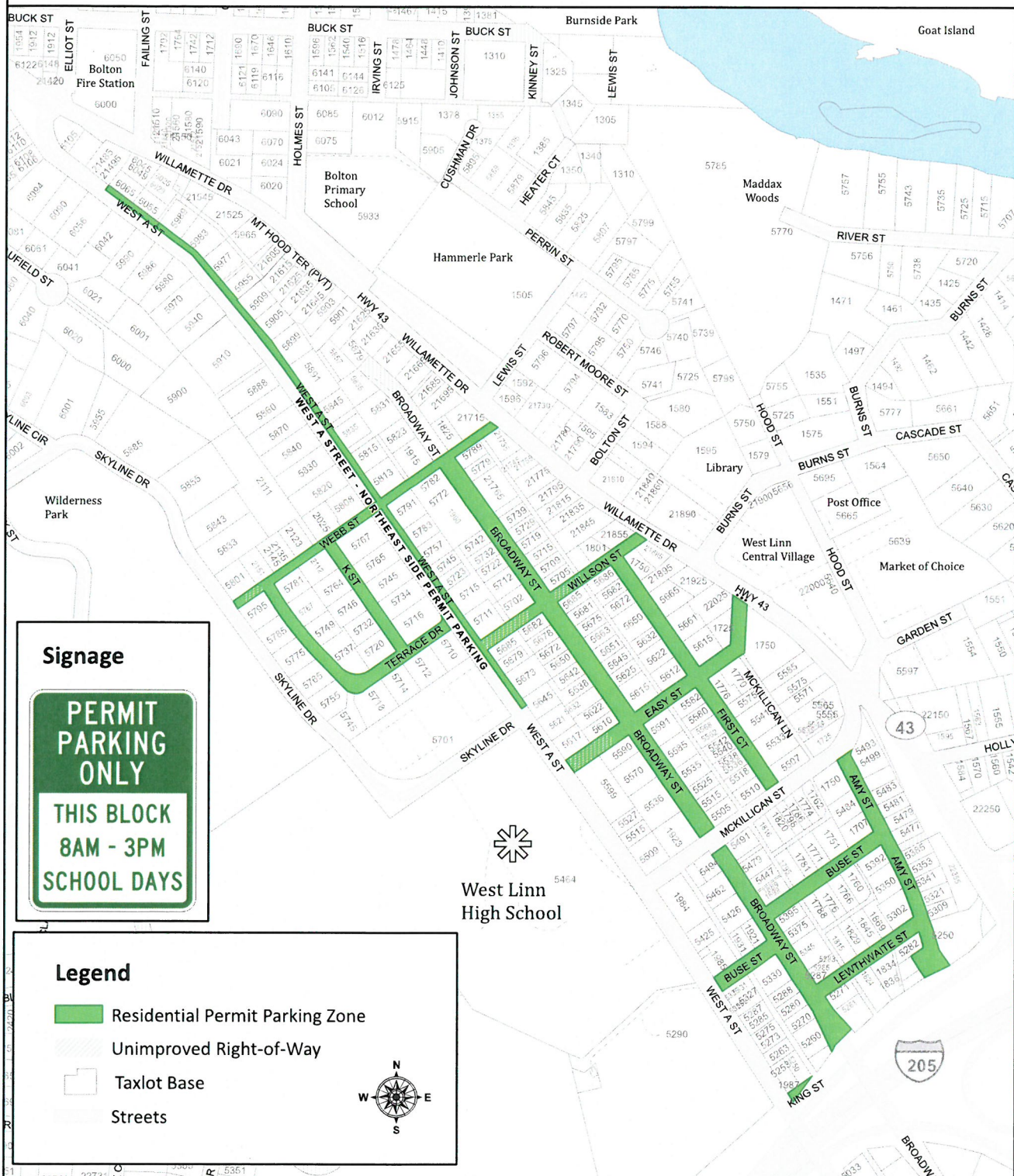
