Subject: West Linn Police 2021 Annual Complaint Review pursuant to OAA 1.7.1(j)

I have completed the West Linn Police Department's 2021 annual complaint review, pursuant to OAA 1.7.1(j). During the calendar year of 2021, the West Linn Police Department received and investigated a total of ten complaints. All ten complaints were citizen-generated complaints. Eleven West Linn Police employees were involved in the ten complaints. There were some cases in which multiple West Linn police employees were involved in the same incident that generated the complaint and the alleged behavior might have been attributed to all employees involved.

Below is a summary table of all ten complaints, including the internal WLPD complaint number, date received, demographic information, complaint status and disposition with disposition date:

In each complaint case in which a final disposition was determined, the complainant was notified of the disposition by Chief Peter Mahuna through certified letter.

It is important to note that the ADMINISTRATELY CLOSED disposition is reserved for those complaints in which after thorough and complete initial investigation no specific behavior from the officer can be identified, that even if true, would result in a policy violation. This disposition can also be used for a complaint in which the complainant refuses to cooperate with the complaint investigation.

In 2021, the West Linn Police Department did not receive any complaints alleging excessive or improper Use of Force.
