## 3. Business:

### a. 2016 Highway 43 Plan

- City staff presented the OR 43 Conceptual Design Plan and discussed timeline regarding when plan would go before Planning Commission and then to Council. Plan is scheduled to go before Planning Commission (PC) in May and it is anticipated that there will be at least two work sessions with PC before the plan will go to Council for review and/or adoption. Staff stated that the City is actively working with ODOT and incorporating feedback on sections that could possibly require ODOT design exceptions. Alan Smith would like there to be more clarification on where pedestrian crossings are going to be incorporated. City staff and members of the TAB clarified that the current plan is conceptual at this point and final design decisions (such as pedestrian crossings)

- The board discussed what tools are available to citizens and/or the city to address ongoing speeding concerns within the city. The board was interested in what safety improvements were planned for Skyline Drive. David Baker mentioned that Burns St. and other narrow roads within the city seem to struggle with speeding, have limited options to address them, and the city is generally not in favor of speedbumps due to the impact on emergency responders and equipment. Members would like to further discuss traffic safety in the future.
