### 1. Call to Order and Introductions

# 2. Review and approval of July 2019 Summary Notes

Greg motioned to approve, Rich seconded. Unanimous approval.

#### 3. Business:

#### a) Main Street Update and Project Timelines

Lance discussed the quickly approaching Jan 2020 construction target start date, and the need for direction from council and TAB to keep the project moving and on track with some big decisions. Feedback from the outreach has a big take away with a lot of hesitations regarding the back in angle parking concept. So a potential recommendation to council will be to opt for a head in angle parking instead, to alleviate some of the initial concern. The project will be designed with both options for parking being possible. The city would have the cost associated to repainting of lines, rather than digging out concrete or curbs if the decision is made. The unique slope of the road and businesses was also discussed and the vertical grade challenges. There is discussion to work with the new construction on 12th to paint that smaller section of parking to be back in angle parking so the community could get used to it in a smaller dose.

Motioned by Greg, 2nd by Rachael to suggest to council to move forward with a trial of back in parking. Unanimous approval.

# b) Projects Public Engagement and Outreach

Continuing with the discussion of information on the bike lane. Outreach has begun with Main Street for outdoor dining and updating to be in harmony with city codes.

Looking for opportunities to do extra for the Main Street area during the project to help with the uneasiness were discussed.

## c) Continued Discussion of Ped Crossing Guidelines

Discussed the ongoing effort to provide more objectivity to improvement requests with data. Previous discussions were on the suggested scoring and ranking system. Streamlining verbiage and be intuitive for all to understand. Motion to continue the current effort to use the rating and ranking system when evaluating prospective improvements made by Andrew, 2nd by Mary. Unanimous approval.

# d) Arterial Roadway Preliminary Design Open House Update

No additional open house for WFD will be scheduled until the project is closer to construction.
