TRANSPORTATION ADVISORY BOARD MEETING Summary Notes

1. Call to Order and Introductions

Called to order by Greg at 6:05pm

2. Review and approval of December 2021 Summary Notes

Pending date and spelling corrections and correction of #4 to “intergovernmental agreement” instead of cia.

Rich motioned to approve, Melissa seconded. Unanimous approval.

3. Business:

a) Election of Chair and Vice Chair

Rich nominated Greg for Chair, Melissa seconded. Unanimous approval

Kevin nominated for Vice Chair, Greg seconded. Unanimous approval

b) Meeting schedule discussion

Approved standard schedule of 4th Wednesday of every other month.

c) Tolling Discussion

Staff gave a brief update on discussions that are happening at the Metro and State level. Greg DiLoreto gave a summary of information he heard at the ODOT town hall meeting regarding tolling. The committee discussed the impacts the tolling will have on the City of West Linn.

d) GO Bond Transportation Project Update

Staff is preparing a presentation to give to City Council on the GO Bond projects which include transportation projects and invited the committee to attend the meeting. Staff is also working on a presentation to City Council on the 10th St corridor project, which is a bigger project than the Willamette Falls Drive project

from 10th to 16th. The “Main Street” project is largely completed. All of the other projects are currently in design. The projects need attention from City Council on the financial end. The projects are coming in at a much higher expense than originally included in the 2018 bond package because of inflation, and the additions to the scope and scale of the projects. These projects are also underfunded due to the bond only covering a portion of the overall project costs.

4. Capital Projects Update

Staff will make a presentation to City Council later in March for a large capital project for Willamette Falls Drive along Fields Bridge to make improvements where the new middle school will be located. This would include a curb, separated bike path and side walk along the Fields Bridge frontage. It would also include a mini roundabout on Willamette Falls Drive at the Tualatin River.

Hwy 43: The design is nearing completion. Staff is managing design differences with ODOT and the design cost are 50% of construction cost. This project has been scaled back in scope and currently includes the portion of Hwy 43 between Hidden Springs and Cedar Oak and the traffic signal at Marylhurst. Staff is working on design and right of way acquisition and ODOT is working on everything along Highway 43.

5. Board/Discussion/Announcements

Staff will send out a new Board roster.

Greg will represent the Transportation Advisory Board on a House Bill 2001 committee aimed at adding more housing options in West Linn.

City Council is holding a goals retreat to discuss goals of the council.
