## 1. Call to Order and Introductions

## 2. Review and approval of October 2022 Summary Notes

## 3. Public Comments

## 4. Business:

### a) Annual TAB Council Report

Greg drafted the annual TAB report to be reviewed and revised by the Board. Rich would like the joint meeting with City Council added as an accomplishment. Rich would also like to add a challenge of achieving the Pavement management rating goal. In addition, Rich would like rewording in another areas. Kim and Melissa would like more direct wording asking City County to come to a resolution on the TAB suggestions to council. Greg will provide staff with a list of edits.

### b) Roundabout Policy Discussion

Staff brought samples of city policies regarding roundabouts from 3 different city/counties to review. The Board would like staff to take Clackamas County and Bend policies to work up a recommendation for the Board to make to staff. Kittelson will make a presentation to City Council in April, and the Board can tie their recommendation regarding the city policy for

roundabouts at the same time. The proposed policy will be on the next agenda for further discussion.

### **5. General Capital Project Update**

Staff gave a brief update including a list of streets that will be paved for the 2023 road resurfacing program. Staff has a meeting with the consultant regarding the projects. Hwy 43 project from Cedar Oak to Marylhurst: ODOT has almost finished their design, and ODOT is moving forward with their right of way acquisition. And City Council has adopted an updated maintenance agreement with ODOT through that section. The Old River connection on Hwy 43 is on hold right now. The Robinwood N/A is considering a request to restart the intersection design. Staff also mentioned the concept drawing for Volpp St. is finished and staff is working on the planned community outreach. The Board would like to know when the next TSP updates are scheduled.

### **6. Board/Discussion/Announcements**

Greg sat in on the public hearing for the I-205 tolling. Greg said they are listening to opinions, but the census is that the polling will proceed.

This is Kim Bria's last meeting on the Board.
